WHEREAS, IN ORDER TO ASSIST Ohio Deferred Comp with its immediate communication needs to county staff and county employees regarding the law change and the expansion of allowed plans within the OHIO Deferred Compensation Plan to include the Roth IRA option;

<u>Section 1.</u> This Board hereby authorized and endorses by vote that this county shall expand the OHIO Deferred Compensation Plan to include the Roth IRA option pursuant to Ohio law.

<u>Section 2.</u> This Board directs the administrator of the OHIO Deferred Compensation Plan, to contact county staff and employees regarding the new Roth IRA plan option so employees may become fully informed as to their retirement options.

<u>Section 3.</u> This Resolution was adopted in a regular or special session of the Board in full compliance with Ohio's sunshine laws.

Mr. Schlumbohm is attending the Tax Incentive Review meetings at the CIC office.

Kevin Niese of Technicon Design Group called in to talk to Commissioners Schroeder and Lammers and see if they were in favor of resuming the Courthouse project. The Commissioners said with the uncertainty of weather in March it would be best to wait a few more weeks to ensure there would not be a freeze. Mr. Niese also asked about the progress for the Annex. Tim Schnipke joined the meeting. The Commissioners want an accurate estimate for repairing the Annex. Two options for repairing the brick exterior were given, both are expensive options. The Commissioners are in favor of proceeding with the project. The Commissioners will hold off on redesigning the offices in the courthouse until the Annex condition is confirmed.

Tim gave an update on the Sewer meeting with the Village, he thought it went very well and the Village agreed to work with the County during the pump station repairs to help reduce the costs. Tim said the Village would be willing to take over the sewer once all the repairs and requirements are met. Tim also talked about a pump on Sewer Dist #1 there is something in the pump that makes it draw more power it is thought to be a towel or bedsheet they are hoping to get the issue taken care of possibly with a vac truck and clear the line. Methods for raising the manholes were discussed. Tim brought up the landfill and the sampling site for the ditch needs

to be built up a bit to make it accessible to get to the water outlet. Cleaning the recycling area was discussed and new water lines need to be run. The floor scrubber is being repaired to be used, some other options are being looked at also. A push broom would work too if there is a person available. New tires will be needed for the skid loader soon.

Tim brought up the rental space at the Ag Complex and there is space that needs to be cleaned up to be available. There are two interested parties in the space.

The business agenda was held with Commissioners Schroeder and Lammers, and Cindy Landwehr, Clerk.

The minutes from Thursday March 5, 2020 were reviewed and approved.

Commissioners Schroeder and Lammers held a teleconference with Allen County Commissioners Noonan and Sneary to amend a resolution for Cranberry Creek.

Mike Klear stopped in to talk to Commissioners Schroeder and Lammers regarding the Continuation of Operations plan if something would happen within the County. Mike just wants the Commissioners to think about if something would happen, would the county offices still operate, would the employees still get paid, if there was an office of employees that were quarantined. Joe Burkhart joined the meeting. Would employees be able to work from home? The Commissioners are not in favor of opening the way to let employees work from home. A meeting will be set up with the Health department and other Health officials to determine the severity and if there is a need to close down offices. The discussion of closing schools was also had. This is all a hypothetical situation, but the departments do need to have plans in place. The Continuation of Operations Plan has a chain of command included and if the location would have to move. The Governor issued a state of emergency to speed up the funding for a situation if needed. The County is required to provide essential needs to people who are quarantined. Mr. Klear wants everyone to be aware and to think and plan ahead. The County's current plan was written in 2009 and the plan will be reviewed to see if any updates are needed.
