He discussed things going on in their office currently. Ohio Business Spotlight Program is still going. He will be working with the Ottawa Chamber to discuss some businesses. Cyber security is one of the biggest issues they are working on. They got the money used for the cyber security list the state provided and they have about \$8000 left and that can be used for physical security and will need to be used by end of June. He said they are working with them yet on that too. \$25,000 was given to Putnam County BOE. He said it will be important to keep voting in person as an option in November. Maybe they could combine polling locations to have less poll workers since the average age is 72 for working. Looking into expanding the poll worker age to a Junior in high school that are in Government classes and maybe their teacher would give them extra credit for doing that and have some recommendations on who would be a good fit for that. They would be used mainly for directing people to go, not being in front of the computers. This would help with the COVID-19 since the older poll workers had to worry more about being exposed. John Schlumbohm said they had a lot of questions come in to the Commissioners Office to ask about a candidate that sent campaign support letters for the position he was running for and he also included applications for absentee ballots. Was this ok? Jacob said it was allowed. If any other questions or issues come up, reach out to Jacob Huner and he would be happy to help.

Commissioners Schroeder, Schlumbohm and Lammers attended a final ditch hearing for the Shane Howell Ditch #985.
