Mr. Schroeder called the meeting to order with Mr. Lammers via teleconference by reciting the Pledge of Allegiance.

Commissioners Schroeder and Lammers held discussions on Recycling and trying to get some new employees.

Commissioner Schlumbohm joined the meeting via teleconference.

The business agenda was held with Commissioners Schroeder and Schlumbohm and Lammers both via teleconference and Cindy Landwehr, Clerk.

Board of Elections members Carla Tooman and Tony Schroeder met with Commissioners Schroeder and Schlumbohm and Lammers – both via teleconference to discuss employee compensation. They are reorganizing their Board for the new term. Kurt and Cathy were unable to attend the meeting today. The reorganization meeting will be March 5. The BOE staff noticed that there will be a 3% excess left in the budget after this year. They would like to inform the Commissioners of their actions. Some other County offices including the Commissioners have given larger raises than the recommended 2% increase. The BOE would like to give their employees a 3% increase in wages rather than the 2%. The Prosecutor, Commissioners and Engineer gave larger raises. The BOE did replace one of the employees that retired with bringing up a part time person to full time at a lower wage and they did use poll worker for added workers when needed. The part time position was not refilled. They do not think they need to hire to replace they are hoping to fill the positions with the poll workers helping out. And it being a light election year in 2021 will help with the expenses also. Since the money is already appropriated in the line item they can use it. The Commissioners were asking if they would do anything they want anyway, even without the Commissioners approval. All the employees did get the 2% increase and they put in extra hours in 2020 for additional voting hours with evening hours and weekends. The Board would like to give them the additional to give the employees a full 3% increase. The other Board members that are not present are also in favor of the increase. Putnam County was #1 in voter turnout and were very efficient in the whole voting process. The employees have had to increase their duties with cleaning and teaching. There was an issue with receiving the comp hours for COVID with the employees also. The BOE thanked the Commissioners for their help in getting the drop box and the other efficiencies with combining polling locations. The BOE did return funds back to County General for 2020. The Commissioners will have to review the figures and then make a decision for the Board of Elections before their March 5 meeting. The voting machines and software being used was also discussed. The Commissioners want the BOE board members to convey their Congratulations to the BOE staff on their job well done in 2020.
