Mr. Schroeder called the meeting to order with Mr. Schlumbohm and Mr. Lammers by reciting the Pledge of Allegiance.

Commissioners Schroeder, Schlumbohm and Lammers attended the Elected Officials meeting.

Tom Wank of Miller City stopped in to talk to Commissioners Schroeder, Schlumbohm and Lammers regarding a ditch project. Mr. Wank had an 8" aluminum drainage pipe that was destroyed in a project and he is not happy with the replacement of a plastic pipe. If he wants it back the way it was, it would be his expense. The Commissioners said as long as the replacement is comparable to what was taken out in size and capacity. All pipes being replaced now are using double wall plastic and not aluminum. The Commissioners believe the plastic pipe would last longer than the aluminum. Mr. Wank still wants the aluminum pipe. Mr. Wank said it is leaching under the pipe. The Engineer will have to go out and look at it closer to see if it was installed properly. The types of tiles used was discussed as to the durability and life.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

Lori Rayle met with Commissioners Schroeder, Schlumbohm and Lammers to review her document scanning proposals. The quotes came in higher than what was thought. Lori is breaking down the items in the quote so she may not need all the services that are included. She is hoping to get the abstract books scanned as well as the deed books. She is hoping to just pick the services that are needed and not pay for extra services that are not needed. Scanning and digitizing is the preferred way to update the books rather than physically replacing the books, which would still require people to come in in person to do research. There is a gap in the availability of deed books online, Lori is hoping to close that gap of availability. There are mortgage books that need to be scanned also but Lori said her department can scan those. This expense for digitizing could be covered by the COVID funds. The Recorder's budget could cover the software expense. The Commissioners said to have her get it all done for updating the abstract and deed books and getting them all scanned. Lori will get a more detailed quote.

The minutes from Thursday May 27, 2021 was reviewed and approved.

The second hearing for CDBG Allocation PY 21 was held in the Assembly Room.
