Mr. Lammers called the meeting to order with Mr. Schlumbohm and Mr. Schroeder by reciting the Pledge of Allegiance.

Commissioner Lammers shared news from the Health Board meeting from Thursday August 12, 2021. The septic maintenance plan and financial status were reviewed.

Ashley Siefker met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the TID (Transportation Improvement District) Board update. The creation of this board is very complicated, by-laws need to be written and adopted. Ashley said there is a consultant who can be hired to assist with the creation of the TID. The Commissioners will need to pay for the consultant. The CIC is pushing to get this created to get it up and running. The Commissioners think the TID would be beneficial to the County. The TID projects would be tied to job retention and creation. Ashley is asking for assistance for the creation documents she does not feel comfortable in writing these documents since she does not have a legal background.

Commissioner Schlumbohm attended the interviews for the Director of Office of Public Safety.

This TID creation would be similar to the 6119 sewer district. The TID would be contained within Putnam County. The Commissioners in favor of the TID to benefit the County. Ashley also informed the Commissioners of the board members that can be on the board. A question of who can be appointed to the TID board was discussed. The State Senate and Representative can each appoint a member to the County's board. Ashley read a legal opinion that a commissioner cannot simultaneously sit on the TID board and the Board of Commissioners. There are some differing opinions on whether or not the Commissioners can sit on the Board. The opinions will have to be reviewed for a definite answer. The Commissioners do not want to create another government entity that will be a burden to the future citizens. Ashley has not approached the consultant yet, she wanted to ask the Commissioners first. Vince asked about contacting CCAO also for some advice. Ashley also asked about the public notices and meetings for this TID board creation. The Commissioners will meet with the Prosecutor to get his opinion. The Commissioners want to get some advice prior to hiring a consultant. And the ARP funds are not eligible to use for these expenses. The engineering costs would not be included with the project costs the communities would need to be able to pay them. The scoring point for the TID projects was also discussed, Ashley thinks it would be more beneficial to the communities that cannot apply for the CDBG funding due to ineligibility, possibly the townships. It was recommended to have Greg Luersman on the TID board with his Planning Commission & GIS experience. There is no grant money tied to the TID. It will not be CIC driven it will be County driven, the board members should be County employees due to liability issues and coverage.

Tim Schnipke stopped in to update the Commissioners on the repair at the Sheriff's office a new fitting will be ordered and billed directly to avoid the additional surcharge from the Village. Tim also said the paving at the Health dept is commencing and moving along. The first phase of painting is done at the Ag Complex and second is being started. Tim has Vulcan coming next week to work on the risers at the Ag Complex for the fire suppression system. Flow switches need to be added to the riser rooms to help identify flows and if and leaks occur. There are 16-17 riser rooms. The fairgrounds has hired a new maintenance person Dave Williams from Columbus Grove. All-Temp is putting together the prices for the new individual units in the courthouse. Dale's Concrete will stop to give quotes for the Sheriff's office for repairs. Tim explained the remedy for excess humidity at Home Health & Hospice. They have set it to run through the night to reduce the humidity. Vince asked about installing a dehumidifier on the a/c unit Tim said that would be more costly. Some other options were discussed.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday August 12, 2021 were reviewed and approved.

Dylan Borchers, Andrew House and Jeff Reinkemeyer of Avangrid met with Commissioners Schroeder, Schlumbohm and Lammers and Greg Luersman to give an update on the Powell Creek Solar Farm project. Andrew is joining the project. Jeff gave an update on the power siting board opinion, there were no comments submitted. The plan is to move forward with procurement of the contractors and the bidding process. Formal approval will be coming in the fourth quarter this year. Target start of construction is a year from now. They are hedging against the price increases for construction. There is a power purchase agreement in place. And a public comment was released. They are down to internal processes. The template for the Great Bear project will be used as a sample agreement. The transfer of the PILOT to the QAQDA will need a compensation agreement. A sample compensation agreement was presented for review. The conditions for OPSB were reviewed and discussed. A pre-construction meeting will be held to review and address the conditions. The compliance filings will be made with the OPSB. Jeff & Andrew will be presenting a donation to the Miller City Fire Department this evening. Future development was brought up.

Mr. Lammers moved to go into executive session with Commissioners Schroeder & Schlumbohm, Greg Luersman, Dylan Borchers, Andrew House & Jeff Reinkemeyer to consider confidential information related to the specific business strategy, of an applicant for additional economic development assistance, and to negotiations with other political subdivisions respecting requests for economic development assistance.
