Brandi Anspach, Brian Siefker, Brad Nelson, Brad Brubaker met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the 2023 budget. The Commissioners are happy with what has been submitted. The Commissioners asked about the staffing and employee turnover. There is high employee turnover. The cost of living here is good compared to the big cities. It is hoped the economy will slow down and the job situation will get better. There are trying cut back on gas use. It was brought up to open a gov deals account for selling

county vehicles. The budget figures were discussed and they are staying on track so far. There are jail suppliers that are increasing prices so that will create an issue. The average number of inmates is about 30. The current staff is new employees who need training. The uniform expense will increase due to all the new hires also. The Sheriff and Jail were the only departments allowed an across the board increase of 5% on all expenses where all the other were limited to a 3% increase in wages only. The union contracts are on the second year, next year negotiations will begin again. There is talk of having a state police department, but it is just talk at this point. The Commissioners do not want to have to cut the budget and have layoffs they are trying to plan ahead. The sales tax revenue had been above the projections so far. It was asked, who is the highest authority in the County, if the FBI is investigating within the County. The Sheriff would be the authority but he would work with the FBI. The question of illegal immigrants coming to the area and their activity was discussed. There are no known homeless in the County. The money for the vehicles was discussed. There will only be vehicles purchased with ARP money for 2022, 2023 vehicles will come from the regular budget. Three will be purchased for 2022 and two for 2023. The Commissioners commended their work.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

Commissioner Schlumbohm received a request to have log jams removed from the Blanchard River and Hancock says there is no money left in the fund. Hancock is the lead County and must be in favor to assess the watershed along with the other counties involved. He will contact Hancock County to request the assessment.
