Tim Schnipke stopped in to present quote to the Commissioners for replacement windows at the Office of Public Safety. Tim also got a quote from Morelock on sealcoating the parking lots. There are some cracks in the lots. Tim is thinking more on crack filling rather than sealcoating. Tim will ask the Engineer if they can use his equipment. The lots he is looking at is the Courthouse, Jail, O-G Road. Tim has an updated quote for the four power pole replacement at the fairgrounds. Tim had a quote for burying the electrical lines also. There are specs for boxes on the parking lot lights also.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Tuesday April 25, 2023 were reviewed and approved.

Commissioners Schroeder, Schlumbohm and Lammers and Alaina Siefker interviewed Diane Merschman for a recycling sorting position.

Mike Schroth, Dog Warden met with Commissioners Schroeder, Schlumbohm and Lammers to discuss personnel. Mike is looking to hire a part time person to help with dog license checks. He did not get many responses. He did find one applicant that is interested. This person is not deputized, but does have experience with dealing with difficult and unruly people. Mike will start the person at the recommended starting rate with an option to increase if job performance within probationary period is exemplary. Mike will start him out with making phone calls. The Commissioners asked about filing charges for the dog license delinquencies. Those charges must by delivered personally and people are not responding to the notices. Mike also brought up the use of this truck, which is set up for law enforcement. Mike asked if his assistant could use the Commissioners' truck if it is available. The Commissioners said yes, he can use the truck as long as it is available.

Tim Schnipke stopped back to ask about the paving again. Is paving going all the way to the LP lot and if so, is the underground electrical included with the bid? The electrical is needed for the camping spots. The electric pedestals would be back-to-back for nine camping spots. And this electrical work would need to be inspected. If the camping spots would be moved there is sewer lines and a lift station that would need to be moved also. Tim will think about it over the weekend to see if any other changes could be made. The parking needed during the fair was discussed.
