Kevin Niese called Tim during the meeting to verify amount of asphalt for the project. The plans were reviewed. There are plan pages that show the alternate project specs. This will repair some of the existing pavement that need to be redone anyway. Kevin said he is also requesting subcontractor listings for review from the low bidder. By next week the Commissioners are hoping to have the demolition bids awarded. The testing results should be in this week for the contractors to complete their bids.

The Commissioners attended the Elected Officials meeting in the lunch room hosted by Commissioner Lammers.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday April 27, 2023 were reviewed and approved.
