Troy discussed the details of the demolition portion of the project with the Commissioners. The crushing of the block and concrete was discussed.

Commissioner Lammers will view the roads near the dairy farm and he will contact the dairy owner to have him come in to discuss a designated truck route.

Jeannie Wolf with The Findlay Courier met with Commissioners Schroeder, Schlumbohm and Lammers to talk about the Fairgrounds project. The Commissioners shared the plans for the project of demolishing the current Junior Fair and Merchants buildings and building one new larger building in their place. The current buildings are in need of extensive repairs and some are beyond repair. The use of ARP funds for the new building was discussed that it will be a possible vaccination site or quarantine site if ever needed again. This new building will have accommodations for both uses, with a kitchen, restrooms with showers and drive-up access. The Commissioners hope it will be used as much as possible and will become self sufficient in operating with the rental income covering the operating expenses. The Commissioners also mentioned that the grandstand will also be getting rehabilitated during this same time. Some photos of the structures were viewed. The fairboard will be the managing entities for the use of the building. The new building will be completed June 1, 2024.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Tuesday May 2, 2023 were reviewed and approved.

Tim Schnipke stopped in to talk with Commissioners about sealing the sewer pipes at the Health Dept. The risers are set on the manholes at the fairgrounds. The fairgrounds drives will be paved next year hopefully when the parking for the event center is done. The water usage at the Records building on Third street and at the Annex were discussed. Tim said a repair was done at the Annex to repair that leak, the Records storage building will be checked again for any leaks. The water usage at the fairgrounds was discussed. Tim is getting quotes for a new generator at the Jail. The new mower is in. The next maintenance truck is built but not delivered yet. The lead test results from the building demos at the fairgrounds were discussed. Tim asked about the dirt that will be taken out of the current parking area when the ground is prepared for

paving between the Ag Complex and the fairgrounds. Tim will meet with Andy from County Electric to reroute the electric for the camping area getting moved.

Commissioner Lammers viewed the condition of Road 22 near the dairy farm.
