Steve Miller, and Tim Schnipke met with Commissioners Schroeder, Schlumbohm and Lammers to discuss replacing the roof over Home Health at the O-G Road Complex. Steve presented some info for a metal roof. Sleepers would not be needed if it is a solid surface. 26gauge steel would be used. The shingles should be removed to see the condition of the sheeting underneath. Metal has a 45-year guarantee on paint, shingles would not have that guarantee. The thickness of the existing sheeting was discussed, It was thought to be at least a 1/2 inch. Steve presented information on a couple brands of steel roof. Tim presented Steve's guote for the roof replacement. Tim said sheeting replacement is not included in the guote. The material of sheeting is thought to be aspenite rather than plywood based on the age of the building. The quote is for \$70,000, which included removing the shingles. The Commissioners thanked Steve for his work at the Fair and the use of his equipment. Steve is booked up and he will see if he can get to it this year yet. October would be the earliest he could get to it. Steve is installing the Bilco door for the EMS house also. Tim also showed a sample of the material used to line the sewer pipes at the Health Dept. Tim also brought up the other sewer lines that have been creating issues, Tim has had the lines cameraed to see the issues. Tim said the fairboard is harvesting things from the Jr. Fair and Merchants buildings and plan to be done by Friday. Cogley's are on schedule to start demolition on Monday.

Tim is getting quotes for repairing his new truck bumper. Tim has an invoice from the Concrete Couple, the intraseal was not added to the cement and he did not take it off the price. The price of the cement was increased to absorb the adjustment for no intraseal. Tim also presented a quote for a new plow for the new truck to purchase next year.

Tim said the electric work at the fairgrounds is getting done. The electric service is moved and the pole may need to be replaced before the fair next year. When the pole is replaced the power will need to be shut off for a day or so.

Cogley asked about the grindings for the demolition they are to be put behind the Ag Complex to be used for the parking lot. The fence will be put up within the week. The traffic flow on the Fairgrounds for the Republican chicken barbeque was discussed.

Tim asked when Recycling is starting their drive through service. Commissioners said when the recycling bins arrive. Tim said the bins are here and have been for three weeks. A new fork lift is needed to handle the new bins since they are bigger. The current fork lift is too small and it is unsafe for moving the bins.

Ron Knippen, Norm Fischer, Jerry Paddubny of Jennings Township stopped in to talk with Commissioners Schroeder, Schlumbohm and Lammers regarding the West Jennings Creek ditch project. The gentleman heard the ditch is going to be cleaned. They wanted to share their issues with Jennings Creek. Mr. Knippen shared a map showing the project area. He stated that Jennings Creek cannot handle the water that will be added from the West Jennings Creek project. It was recommended to put in retention ponds to regulate the water entering Jennings Creek and the Auglaize River. Jennings Creek project stopped at the Putnam County line. Ryan Moran joined the meeting to explain the role of Putnam County in this ditch project. Ryan can check with Allen County and see what kind of maintenance is being done for the Putnam portion of the Jennings Creek, since Allen is the lead on the Jennings Creek. Van Wert will be the lead on the West Jennings portion. Mr. Fischer said Jennings Creek is getting more and more water and cannot handle it. Mr. Knippen will be the contact person on behalf of these landowners for relaying the information the Ryan receives from Allen County. Ryan will find out if a maintenance request needs to be filed with Allen County.

Rev. Denny Coates stopped in to talk to Commissioners Schroeder, Schlumbohm and Lammers regarding the Putnam County Veteran Services participating in the God & Country night at the Fairgrounds. They did not participate in the program because it was called God & Country. The Commissioners recommended going straight to the Veteran Service Commission Board to voice the concerns and disappointment about not participating in the program. There was a malfunction with one of the fireworks and thankfully no one got hurt.

Tim came back in to inform the Commissioners of a drainage pipe needing repaired at the landfill.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday June 29, 2023 were reviewed and approved.

The Commissioners discussed setting up a future discussion regarding future solar farms.

A bid opening for the 2023 OPWC Paving Project on Rd. B was held with the Commissioners and Engineer. The bids were received as follows:
