The new signs for recycling have been ordered. There are still multiple calls and Tim says people will go in to the wrong areas when any gate is open.

Tim Schnipke met with Commissioners Schroeder and Lammers to discuss maintenance updates.

- Recycling needs more lighting to sort plastics. He submitted an invoice for two more lights.
- Sewer Dist #1 lift station B the new check valves are in. The remaining equipment in the hole will be replaced when the new valves are put in. Tim submitted an invoice for the new equipment that his crew can do.
- Troy Recker submitted a change order for the fairgrounds construction. Tim said the storm drain line was known to be under the building and it should have been figured into the specs. The sewer line should also have been known that it was there since there was a restroom in the building. These are items 4 & 5 on the changes submitted.
- Tim submitted an estimate for more steel siding for the Ag Complex. The steel prices
  were discussed. Tim is figuring to do half of what he submitted. It will get it over half of
  the back of the building. Insulation could be added for the recycling area.
- Tim met with Muhlenkamp at the Grandstand this morning. There is no longer a footer under the front, a new footer is needed. Todd with Technicon is drawing up a design for a new footer. I

Bockrath & Assoc, Technicon Design Group, Helms Construction and Tim Schnipke met with Commissioners Schroeder and Lammers at the Fairgrounds to hold the first progress meeting for the fairgrounds event center.

The business agenda was held with Commissioners Schroeder and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday July 20, 2023 were reviewed and approved.

Mr. Rick Sheaks met with Commissioners Schroeder and Lammers regarding the county's ARP funding. Commissioner Lammers explained the projects where the funding was used. The benefit of using these funds on build a new building at the fairgrounds was explained as a benefit to future citizens. The fairgrounds buildings needed some upgrading. The Commissioners are hoping this new building will create future events at the fairgrounds to increase its use and create revenue. The funds given to the fire departments and telephone

companies for upgrades. Will the new building be used enough? There is a new facility in Leipsic also. The Commissioners said they could not use the funds as a tax holiday and give back to the taxpayers. There needs to be a better way of communicating with people in the county. The newspapers and news are very biased. The pendulum swings both ways in the 60's there were extremes and again in the 80's. The pendulum continues to swing back and forth and the government changes also. Most of the senators and representatives for us are from this area, in northwest Ohio. Mr. Sheaks has tried to contact Rob McColley regarding the real estate tax rates. Mr. McColley has not responded to Mr. Sheaks' inquiry at all. The triennial valuation on real estate was explained. The taxes will continue to go up. The request to Board of D/D to lower the tax levy was explained. Commissioner Lammers will contact Senator McColley and Klopfenstein on behalf of Mr. Sheaks. Mr. Sheaks is being taxed for dog kennels on his property. With the demand in real estate now and the rise in interest rates the whole real estate market could drastically change. Mr. Sheaks said he will make changes to the buildings on his property as needed, by taking down the buildings he no longer needs.

Nolan Croy stopped in to talk to the Commissioners about the upcoming trustee meeting on Monday July 31. He also wanted to inform the Commissioners that he is still waiting on the deed updates from the Prosecutor for the transfer of the property near the airport and old nursing home.

Brenda Keller, Heartbeat of Lima called into talk to the Commissioners about changing their office hours to Tuesday and Thursday from Monday and Wednesday to coincide with the WIC office next door. She wanted to let the Commissioners know they would be changing the hours posted on the window of the building. They will be extending their hours in the Ottawa office also to create more exposure to the public. The Commissioners also asked if they would work with the local Right to Life organization. Brenda was more than happy to do that
