WHEREAS, According to the Revised Code of Ohio, Section 955.14 if in any year there is not sufficient money in the dog and kennel fund, after paying the expense of the administration, the Board of County Commissioners may increase dog and kennel registration fees in the county. The amount of the fees must not exceed an amount that the board, in its discretion, estimates is needed to pay all expenses for the administration of the Dog Law. Such a resolution must be adopted not earlier than February 1 and not later than August 31 of any year and must apply to the registration period commencing on December 1 of the current year and ending on January 31 of the following year, unless

the period is extended as authorized under the bill. Any increase in fees adopted must be in the ratios of \$2.00 for a dog registration fee and \$10.00 for a kennel registration fee. now therefore, be it

Commissioners Schroeder, Schlumbohm and Lammers left the office to view the conditions of Road 12-K in Ottawa township.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday August 17, 2023 were reviewed and approved. Judge Borer met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the Probate/Juvenile budget. There is a need for more money. The Judge said there are some unusual things happening in his court. He has a will contest action trial coming up. He also has a high number of juveniles needing specialized detention services. Juvenile Detention Center is in Wood County, which is Juvenile Jail =\$80 per day. JRC is free to the county, but there is only one facility in Ohio which takes girls. Majority of the cases come from unmarried families and there are also abusive situations. Most of the facilities that accept special needs juveniles are very costly. Youth Subsidy money can no longer be used for juvenile detention services. He needs approx. \$51,000 to complete the year for his budget. The money will be appropriated for County General. Ann did retire and he has an additional clerk. Custody does not have court appointed attorneys. Indigent attorneys do have a capped rate. Ther are fewer attorneys available for indigent/court appointed cases. Judge Borer explained that the law practice has changed over the years and most new lawyers do not want to do court work. There are other avenues available for planning to prevent additional expenses of estate planning. There are more occupations available to make more money, it is not just defined to being a lawyer anymore. The pay scales now are not adequate for new graduates to be able to live and pay off the large college debts.
