Commissioner Schroeder attended Farm Science Review.

Ken Niese & Jerry Westrick met with Commissioners Schlumbohm and Lammers to discuss the screening requirements for the solar farms. Mr. Niese did talk to Avangrid about the screening. A picture of a solar farm in Hancock County and the screening that is planted there was submitted as a sample of what can be done. The Commissioners explained that the required setbacks are being revised on today's agenda. The Commissioners just want the landowners to take the neighbors into consideration. The screening will be on all sides of the solar farms, road frontage and property lines. Avangrid is interested in good will. The Commissioners did away

with the PILOT payments to discourage new projects. Since the coal plants are being shut down and the gas plants also the electric rates are going up even for the co-ops. Nuclear power is up and coming for power supply. Ottoville resident have contacted the people from Miller City to see how things are going. The trustees have the authority over the small solar facilities. Since the Commissioners killed the AEZ and are revising the regulations, it should be more fair for both sides. The sewer system that was originally proposed to Miller City has changed as well as the cost. The initial solar facility was supposed to cover the cost and now an expansion was proposed since the cost of the sewer system has increased.

Kim Redman met with Commissioners Schlumbohm and Lammers to discuss the vacation accrual for employees. Kim presented a comparison of vacation accrual with other counties and entities. Kim is proposing at 6 months an increase in vacation time to encourage employee retention and new hires. Currently a new employee must work a full year to use the vacation earned. Kim has looked at Findlay and Clermont County who use the 6-month term to earn vacation. Two weeks will be given at a year. Maybe at 10 years give another bump. The cost of living here is not bad but housing costs are going up. The Commissioners will review and present the idea to the other elected officials. The Commissioners suggested checking with Mercer and Auglaize counties also. The surrounding counties are direct competition for workers. There is a shift in staffing levels now, it is improving.

Tim Schnipke stopped in to tell the Commissioners that the contractor-Helms wants to meet them at noon at the fairgrounds to show them another footer that was found. The new fence in front of the grandstand was discussed. More siding was purchased for the Ag Complex and the camper electrical boxes will be put back on the posts. The landfill tile is in. The landfill inspection is being done today.

The business agenda was held with Commissioners Schlumbohm and Lammers and Cindy Landwehr, Clerk.
