Alaina Siefker met with Commissioners Schroeder, Schlumbohm and Lammers to inform them of the changes to the wellness program for next year. CEBCO is moving the wellness program through them and Anthem and it will be a rewards-based program with the opportunity to gain \$200 through it depending on what items you do in the list. The support/management will be through Anthem. It is called CEBCO Rewards 200. This will also be done through the Sydney Health App. Information will be getting emailed out soon on this change. Before that email goes out, Alaina wanted to check with the commissioners to see if they still wanted to offer an incentive for doing a blood draw. This year with the change, there will also not be on site draws. Everyone will need to use their physicians for their blood draws. The commissioners all agreed they would still like to do the \$200 gas card incentive for those who do the blood draw since they still feel that the blood draw is the most critical part of wellness. CEBCO would be able to get a list from Anthem on who did the blood draw to know who would get a card. The wellness grant funding amount will not change but the grant agreement will change and we will see what kind of changes that will have probably in January or so. Per the completion list from CEBCO, 2022-2023 Putnam was the top county with 59.8% of employees and spouses that completed the blood draw.

Commissioners Schroder, Schlumbohm and Lammers attended a progress meeting with Technicon and the contractors at the Putnam County Fairgrounds to review the progress on the construction of the new event center and grandstand rehab.

The minutes from Tuesday October 18, 2023 were reviewed and approved.

Commissioners Schroeder, Schlumbohm and Lammers attended the final hearing for the Vincent T. Schroeder Dt # 987. Gene Warnecke sat in for Commissioner Schroeder on this hearing since Commissioner Schroeder is the petitioner and landowner in this ditch.
