Tim Schnipke stopped in to update Commissioners on maintenance issues. There is mixed dirt at the fairgrounds due to the construction and it must be clean fill. Helms will need to clean it up, or the Engineer could use it on a ditch project. Gary Hermiller will start next week to finish the digging at the fairgrounds. Tim said they are working on parking lot lights this week. The roof at O-G road is moving along well. The electrical panel is going into the grandstand. Tim said more spots were identified in the grandstand where the flooring needs replaced.

The minutes from Thursday October 19, 2023 were reviewed and approved.

Jeremy Maag met with Commissioners to inform them of the current balance in the Capital Improvement fund as well as the general fund status.

Commissioners Schlumbohm and Lammers attended a Zoom meeting with Hancock, Hardin, Allen, Seneca and Wyandot County Commissioners to discuss the Blanchard River Stream enhancement project bids and paying for the project. The recommended contractor based on bid submitted was NWO Property Services. Allen County is still questioning the funding from each county if they do not have the funds available. The cash does not have to be in the fund just in the process of collection. The completion of the project would be Nov 2024. Allen county collects per project they do not advance money for projects they collect for projects and then pay for them. The contract is not being signed yet. There could be payments requested prior to the collections coming in. It was recommended to go ahead with the project approval and each county can pay as they go and have funds available for the payments requested. Putnam

County is good to advance funds as needed for this project as they do with other projects. The tax collections are predicted to be delayed due to the changes in the tax rates coming.

Commissioner Crowe moved to proceed and each county per their share of the collections as appropriate within 30 days of collection.
