Commissioners Schroeder, Schlumbohm and Lammers attended a joint teleconference with Defiance and Paulding County Commissioners to award the bid for the Shane Fitzwater Dt # 995. The bid was awarded to Sand Ridge Excavating with their bid of \$ 104,899.60.

Commissioners Schroeder, Schlumbohm and Lammers held discussions with Cindy Landwehr regarding reviewing the Ohio Healthy Aging Grant info. The proposal from Council on Aging was reviewed. The Commissioners are in agreement with the proposal and having the Council on Aging conduct the grant with the reporting done by Cindy in the Commissioners' office. The disbursing of the funds was discussed and who will be paying the vendors. The Council on Aging will be paying the vendors and providing the data to the commissioners' office for the quarterly reporting. Cindy has talked to the auditor's office about setting up a fund for these monies. Cindy will inform Jodi that they can proceed with the grant activities.

Troy Recker stopped in to inform the Commissioners of the contractor's performance on the Sewer District #1 project. Ward Construction did not take enough materials off the existing streets. There are areas where the road is too high where extra work will be needed by the trustees now. They are trying to come up with other solutions to prevent increased costs to the project. The trustees have a list of needs for the roads now, they want a new berm on the road. No asphalt overages are being paid for. There is concrete gutter that will be broken up by Hohenbrink, about 500 ft. The existing drains will need to be relocated. The concrete gutter is on the east side of Sunset drive. Replacing topsoil to support the berm to prevent a big drop off on the side of the road. The contractors are responsible for the extra costs due to not following the specs. Ward Co. is refusing to bring the grinder back in to fix the asphalt level The milling is being paid for 2 inches but it was not known how much was actually done. Hohenbrink is the primary contractor and Ward is a subcontractor for the paving. Troy wrote up an agreement with the contractor to complete additional the work needed.

Commissioners Schroeder, Schlumbohm and Lammers held discussions on increasing the mileage reimbursement rate. It was proposed to increase the mileage rate to \$.45 per mile due to the increased travel costs. It was also proposed to increase the meal reimbursements per meals and per day. The total meal increase was \$5 per day increasing each meal to \$11 for breakfast, \$14. for lunch and \$20 for dinner, making the new daily total \$45.00 up from the current \$40. These changes will take effect as of January 1, 2024.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Tuesday October 24, 2023 were reviewed and approved.

Kim Redman met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the employee vacation accrual. Kim shared three scenarios for accruals. Findlay, State of Ohio Third District court of Appeals, and the Putnam County Sheriff's office were the three submitted. The Sheriff's office is union but the non-union people can use 1 week of vacation after 6 months of employment rather than waiting a full year. When the year is complete the other 40 hours is available to use making up the 80 hours that is accrued throughout the year. Vacation is accrued starting on day one of employment. All that is proposed to change is the ability to use some vacation before a year of employment is completed for a new employee. Changing the tiers of vacation accruals was also proposed to lessen the amount of years worked to accrue additional hours per year. The staffing level is covered by the other employees when an employee is out on vacation to avoid the additional expense of overtime pay. Kim is proposing these changes to keep the employees since there have been many employees that have left employment for better job benefits and compensation. Pay raises that other counties are offering their employees and other compensation benefits, such as bonuses and insurance stipends. The Commissioners will consider these changes.
