Ashley Siefker met with Commissioners Schroeder and Lammers regarding the TID Board.

Tim Schnipke met with Commissioners Schroeder and Lammers regarding the schedule for the new event center. The work is getting severely behind schedule. There are only three people showing up to work each day currently. The cement work did not get done during the nice weather and the weather window is closing. And since the building is not completely enclosed the inside work cannot get started. At the next progress meeting these items must be addressed. Tim said the remaining gates are arriving today for around the grandstand. These delays must be addressed at the next meeting and the Commissioners will contact Kevin Niese at Technicon Design Group.

Ashley Siefker and Tracy Warnecke met with Commissioners Schroeder and Lammers to discuss the administration for the demo grant and the land bank. The costs of having Maumee Valley Planning Commission versus Bockrath & Assoc. were compared. The administration and engineering costs of the grant were discussed. There are differences in the methods of charging by each firm. Trees are not included with a demolition so fees could be established for tree removal. It was guestioned the need to use the landbank based on population per ORC. If Maumee Valley's fees are going to be significantly less it would be effective to use them, then more properties can be cleaned up. The director of the landbank can choose who will be the administrator. Maumee Valley will not charge engineering fees. The engineering will be bid out if needed. The purchasing of land by the landbank after the sheriff's sales and auditor's sale was discussed. If it is not sold at either of those sales then the landbank could acquire the land. The CIC wanted to send a bill for their work on this also. It was asked what their work was. It was explained that the demo grant and the landbank are two separate things but the demo grant will feed the landbank. Since last year was the initial year for the demo grant there was a lot of extra work done that was not necessarily needed. The roles of each entity will be defined to make a basis for charges, demolition, administration or engineering.

The business agenda was held with Commissioners Schroeder and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday December 14, 2023 were reviewed and approved.

Commissioners Schroeder and Lammers held a teleconference with Kevin Niese of Technicon regarding the delays in the construction at the Fairgrounds. There are only 2-4 people showing to work each day. This will be addressed at the progress meeting on Thursday.
