Nolan Croy, Planning Commission met with Commissioners Schroeder, Schlumbohm and Lammers to discuss a proposed variance. Nolan presented regulations from Liberty township for solar farms. The setbacks were reviewed and compared to the Planning Commission regulations. Nolan will suggest a revision of the regulations received. A plat received from Justin Niese that did not have the proper width & depth, the plats were to settle an estate for his clients with no money transfer. The Commissioners were not in favor to grant the variance. Commissioners proposed new lines to make the plats the proper width and depth. The plats should be redrawn to fit the Planning Commission rules. The Commissioners agreed with Nolan to recommend Liberty township rewrite their regulations to match up with the Planning Commission better. Nolan presented an agreement with the Commissioners for an increased rate for pay. Nolan said he was willing to forgo a raise for the upcoming year if the vacation time accrual is revised. The vacation time accrual will not cost more money but it could create some issues with staffing. In the past jobs within the county were fought over, that is no longer the case due to the changes in benefits over the years. So additional vacation time would make the jobs more appealing again. Nolan has performed well in his new position as head of Planning Commission. Nolan also had an inquiry on a possible demolition. The inquiries are being referred to Tracy Warnecke for the land bank. A question of if capping a well was included in the demo grant. They will inquire.

Commissioners Schroeder, Schlumbohm and Lammers attended the Elected Officials meeting hosted by Sherri Britsch, Recorder.
