Miller City High School students visited the Commissioners' office and the courthouse for a field trip. The students sat in on the business agenda and had some questions for the Commissioners. They were encouraged to visit each office and inquire on their services and also view the Veteran's Memorials on display in the lower floor hallway.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk. Dale Schulte, Fair board President sat in on the agenda also.

The minutes from Tuesday January 16, 2024 were reviewed and approved.

Dale Schulte brought up some other issues at the Fairgrounds to inform the Commissioners of other upcoming plans and improvements at the fairgrounds.

Commissioners Schroeder, Schlumbohm and Lammers and Gary Lammers held a teleconference with Bob Zimmerman regarding the Shane Fitzwater Joint County Ditch. Mr. Zimmerman is not in favor of the contractor that won the bid for the project. ORC was followed for the bidding process for the ditch petition. Gary Lammers explained the award process and that ORC was followed by the joint county board for the bidding process awarding the lowest and best bid. Mr. Zimmerman voiced his opinion that he is not in favor of using Sand Ridge Excavating for the project who was awarded the project. Mr. Zimmerman has had experience is using Sand Ridge and he is not happy with their work. The county has used Sand Ridge for many projects and have not had any issues with them and their work. It was recommended that Mr. Zimmerman take before and after pictures of his properties and if he sees any issues that need to be corrected, he must present them to the Engineer. Mr. Zimmerman said he has is own contractor lined up to do his work but the Commissioners informed him that he will still be assessed for the work done on the ditch petition. The Commissioners said if he wants to pay for the work twice that is his prerogative. The status of lowest and best bidder is his opinion. The Engineer will be overseeing this project and will be monitoring the quality of work on this project. if it is not done according to the specifications written it will be done correctly. Mr. Zimmerman will have to mark his outlet tiles as he would for any contractor that does the job.

Commissioners asked Gary Lammers about a resolution for a moratorium on marijuana dispensing within the county. A village would have to pass its own resolution. The Commissioners asked for some examples of other counties that have done this. Gary will do some research. Gary also brought up a message he received from Joe Schroeder, Ottawa's Solicitor regarding an easement for the waterline to Miller City, the solar farm wants to put in a power line under the waterline within the easement. Joe said the Commissioner did not transfer the easement to the Village when the waterline was transferred. It was questioned if this was a road right of way easement, rather than an ownership easement. As long as the land owner does not have any issued with the easement the Commissioners are ok with it. The land swap with Village of Ottawa was brought up also there is some language in the agreement that should be taken out, regarding a buy back for the Village. This language will be taken out.
