That Suzy Wischmeyer, Director of Putnam County Job & Family Services hereby requests authority, in the name of Putnam County, to participate in the Ohio Department of Transportation contracts for the purchase of machinery, materials, supplies, or other articles which the department has entered into pursuant to Ohio Revised Code Section 5513.01(B).

## Section 2

That the Director of Job & Family is hereby authorized to agree, in the name of Putnam County, to be bound by all terms and conditions as the Director of Transportation prescribes.

# Section 3.

That the Putnam County Director of Job & Family is hereby authorized to agree, in the name of Putnam County, to directly pay vendors, under each such contract of the Ohio Department of Transportation in which Putnam County participates, for items it receives pursuant to the contract.

### Section 4.

That Putnam County agrees to be responsible for resolving all claims or disputes arising out of its participation in the cooperative purchasing program under Section 5513.01 (B) of the Ohio Revised Code. Putnam County agrees to waive any claims, actions, expenses, or other damages arising out of its participation in the cooperative purchasing program which Putnam County may have or claim to have against ODOT or its employees, unless such liability is the result of negligence on the part of ODOT or its employees.
