The jams were classified by class A= 1-3 logs, B= 3-6 logs C= 7-9 logs D= 9 + logs, the seeding of banks was discussed. The contract must be agreed upon by all counties included change orders. The assessment will cover the original cost of the project including the change order. The counties must agree on the assessment amount. All counties are in agreement with the funding through assessment. Putnam County has paid their portion. Allen County is waiting on the tax collection to be settled then they can send payment.
