Tim Schnipke met with Commissioners Schroeder and Schlumbohm regarding hiring summer help for mowing. Tim also brought up some issues with the building, that they will view. A new hire would be paid \$15.00 per hour and work 20-30 hours per week. Brad Brubaker joined the meeting. Tim informed the Commissioners that the recycling door got hit that week because the door was not open far enough. Commissioner Lammers joined the meeting. Tim informed the Commissioners about some more repairs that are needed at the Ag Complex building by the renters. The wiring for the hog building will be started and the vendor camping. Commissioner Schroeder shared some suggestions from Don Verhoff, replacing the chain link fence at the back of the fairgrounds, using the fence that was removed from between the Ag Complex and fairgrounds and putting in up in the back. The east side needs new fence. There are gate panels that can be sold, that is up to the fair board to sell. The fencing will be replaced behind the Ag Complex. The Commissioners said a smoke & dye test should be set up with the village for the sewer district. Tim said they are checking over some issues with the new building and hopefully finding the source of the roof leak.

Commissioners Lammers updated Commissioner Schroeder on the casino/local government revenue discussion and that the county is looking into giving more of the local government funds to the townships and villages for added income. Commissioner Schroeder said the townships have their own taxing authority and disagrees with the decision to give them more of the funding.

The plans for a carbon dioxide well for POET was brought up and some information was reviewed.

Commissioners Schroeder, Schlumbohm and Lammers held a discussion on the 2025 budget planning with setting 3% for increase on wages and 10% increase for insurance for a projection and planning. Brad Brubaker sat in on the discussion.

Alaina Siefker came in to let the commissioners know that Kyle Davis called the day before to see if it is ok to have the National Day of Prayer on the courthouse lawn if it is nice out or in the Assembly Room if it is bad weather. His wife is the national coordinator and they are members of Denny Coates church. The commissioners are all fine with them doing that again this year and Alaina will call Kyle back and let him know.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk. Brad Brubaker joined the meeting.
