Commissioners Schroeder and Schlumbohm met with the Joint Board of the Ottawa River: Allen, Hancock, Auglaize and Hardin Counties via teleconference to review work and assessments. The logjams were reviewed and a map of the area of the river was viewed. Allen County ran out of money to remove all of the logjams. The assessments will be discontinued for collection at this time. A future resolution will be needed to set a percentage to collect for an assessment. Current fund balance is over \$241,000 which is above the 10% amount for collection. All counties are ok to stop collection until the fund needs to be replenished. Estimates from Ottawa Tree Service and H & H Land Clearing were compared. Tawa Tree Service is preferred. The counties are in agreement to request a contract. The timeframe of the project was discussed and nothing can be done until a contract is in place.
