Tim Schnipke stopped in to talk to Commissioners Schroeder and Schlumbohm about the additional paving needed at the fairgrounds, the estimate submitted by Helms seemed high compared to Bockrath's estimate, maybe some work swapping could be done to get things finished up.

Tim also said he has someone coming today to look at the Annex roof, the materials for replacing the roof were discussed.

Don Croy and Steve Leopold Ottawa Township and Gary Lammers met with Commissioners Schroeder and Schlumbohm to discuss the Road 12-K ditch layover and the Hamel property. Gary said the letter was sent out to the attorney and no response was heard back as of yet. Gary asked what the next step will be. The trustees said they will just dip out the ditch on the Hamel property. The mediation is schedule for June 25 at 9:00am. Hamel's portion should be dipped. The landowner is responsible for providing the driveway tile whether it be the same tile or a new one. Mr. Hamel's tile happens to already be seconds. If the tile and drive can be moved back it would be better for the project. The portion could be dipped out from the road. The Hamel portion will be dropped from the project and just dipped for the project to start as soon as possible. The trustees originally offered to give an extra 40 feet of covered area on his property. The trustee's feel if no response is received there will be no extra coverage only a dip out. The past negotiations were discussed. Since no response was received Gary will write a letter to the landowner on how the project will proceed without his consent. The driveway tile will be reset to the proper depth and the original tile will be reused if possible. The township is concerned about the ARP funds that are being used for this project still being available if the project is delayed. The trustees have revoked their offer of extra work. The width of the road was discussed and passing on the road is limited due to the proximity of the ditch to the road.

The business agenda was held with Commissioners Schroeder and Schlumbohm and Cindy Landwehr, Clerk.

The minutes from Thursday May 16, 2024 were reviewed and approved.

Commissioners Schroeder and Schlumbohm attended a landbank meeting with Tracy Warnecke, Jim Leopold, Dean Meyer, Estee Blair, Amy Sealts, Rachelle Conine and Griffin Brinkman to prioritize projects for the grant.

Commissioners adjourned for the day.
