Suzy Wischmeyer met with Commissioners Schroeder, Schlumbohm and Lammers to discuss Cecil no longer working at the recycling center and the separation of Job & Family workers from being sorters. The recycling is behind and the Commissioners are hoping to hire full time people to get the program back up on its feet and up to speed. Cecil will go back to doing regular maintenance jobs of painting and community clean up. Suzy said she would be able to keep the group busy doing other jobs. AEP is working on the substation behind the building and using the parking lot across the road from Job & Family so the Job & Family workers have to find alternative parking at this time. AEP sent the County a bill for using the rear drive for the parking lot improvements and AEP did not have permission to use the other parking lot just an easement for along the road. Suzy said everything else is going good. Mr. Lammers asked about the child placement due to the opiate crisis, Suzy said it has leveled off. The unemployment rate is still low. Workforce Development has some new programs coming. The Elevate event went very well and had good participation. The date for separation from the recycling program is projected to be May 1. Suzy said they will take their inventory items with them also.

Jennifer Peryam, the Lima News joined the meeting.

Joe Hohlbein met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the recycling program and the changes that are coming. Another full time employee will be hired to work in the recycle sorting center and drive. Joe has ideas for more changes to make the process more efficient. Joe would be a full time employee also. There are some prospects for the other full time position and some negotiating will be needed. The trucks are going to need some maintenance and service done. The recycling truck needs a new cable, new tires and will need brakes also. Some options for outlets of glass were discussed, that are closer than hauling to Dayton. Dayton is paying \$10 per ton, which is why it is going there. We can haul 11-12 ton per load. There are some new facilities popping up for different materials so the market is changing. Joe will look into getting a magnet for sorting the metals. The location within the building will be changed and the renters will be moved to a similar area for their needs as well. Some doors will need to be made bigger for accommodating the different areas.

Ryan Moran and Jeremy Gerding met with Commissioners Schroeder, Schlumbohm and Lammers to hold a bid opening for the Dan Homier Dt #981 was held. The bids were received as follows:
