**WHEREAS,** The Treasurer of Putnam County has submitted to the Board of Commissioners, her estimate for the aggregate amount of public moneys at any one time during the next four year depository contract to be Twenty Million Dollars (\$20,000,000.00).

**WHEREAS**, The additional services needed by the Treasurer are:

- 1. Wire transfers, deposit slips, handling of deposits, incoming ACH's and redeem county warrants at no charge.
- 2. No charge on electronic federal or state tax payment.
- 3. Provide deposit stamps and deposit slips at no extra charge.
- 4. To provide lock box service and payment of bills through ACH.
- 5. Redeposit NSF check twice before return with no return check charge.
- 6. Supply information immediately of any discrepancies in any bank transaction, including deposit slips and warrants cleared by the bank.
- 7. Cleared warrants are to be viewed on line (front and back) by the Treasurer's office for up to one year at no charge.
- 8. Approximate number of warrants to be redeemed in a period of one year is 27,000.
- 9. Provide a monthly bank statement with CD of canceled checks.
- 10. Direct deposit of payroll to various banks.
- 11. To provide money bags, straps and coin wrappers at no extra charge.
- 12. To provide internet banking and internet software training at no charge.
- 13. To have adequate collateral on all deposits at all times, as per Ohio Revised Code.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers, Cindy Landwehr, Clerk.

The minutes from Thursday April 16, 2020 were reviewed and approved.

Commissioners Schroeder, Schlumbohm and Lammers met with Tracy Warnecke, Treasurer and Bob Benroth, Auditor to discuss the county investments. The Commissioners and Tracy reviewed the Counties investments and amounts that are already within the County banks versus Star Ohio. The Commissioners are concerned about the economy and the state of County's funds bringing as much back to the County as possible. Bob Benroth joined the meeting. On interest rates the local banks might not be better than Star Ohio. The money should be secure with Star Ohio. The rates at local banks could be the best rate depending on how things play out. The Commissioners would like Tracy to look at more local banks for investmenting more money locally.

Bob brought up the County Fair and if they are going to hold it or not. The decision is still pending. The meat producers within the Country was discussed.
