The Governor's final decision was discussed as to the determination of why the recommendation was relaxed. The National Day of Prayer celebration was discussed and since the Governor's limited on public gatherings of more than 10 people has not been lifted the Commissioners are not in favor of it being held at this time.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers, Cindy Landwehr, Clerk.

The minutes from Tuesday April 28, 2020 were reviewed and approved.

Commissioners Schlumbohm and Lammers called Brad Alt about a position in the Recycling Center.

State Auditor, Brenda Troyer came in to talk to the Commissioners Schroeder, Schlumbohm there is an audit charge involved with them. The audit will commence and hopefully be completed by July. Brenda presented the audit letter to the Commissioners to sign so the audit can officially commence. Some of the changes in the grant programs were discussed.
