Commissioners Schroeder, Schlumbohm and Lammers attended the Elected Officials meeting in the lunch room. They shared the updated procurement policy for the county.

Tim Schnipke stopped in to present quotes from Border magic for landscape edging for the courthouse and repairs to the leachate pump. Tim explained the repairs for the leachate pump. Tim also had quotes for the Health Dept parking lot from Ward and Morelock. Ward says we need an additional catch basin for drainage. Morelock thinks they can make the existing one work. Tim will double check the figures.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

Commissioners Schroeder, Schlumbohm and Lammers held discussions regarding the recycling truck and a possible recycling bin for Nelson Manufacturing. The Commissioners don't have the specifications for the bins yet. Once they get them, they can forward them to Nelson for a bin to be made. The new truck is built and is in Springfield. Rush Trucking will let us know when it arrives in Lima so we will know when it is going to Kalida for the equipment. We will let Nelsons know once we have the hook on the truck to know how that will need to be done for the bin they want to purchase. The commissioners will be talking to Joe Burkhart IT to see what he recommends for a virtual timeclock for recycling.

Ryan Verhoff met with Commissioners Schroeder, Schlumbohm and Lammers to discuss employee insurance. Ryan explained the grant cycle for funding also. Next year additional funding would be needed from the County since the grant cycle will be over. The Commissioners said to make a note on it for the next budget request.

The minutes from Thursday, April 1, 2021 were reviewed and approved.

Bob Benroth stopped in to discuss the 2022 budget. Bob said to remind the offices that there will be 26 pays in 2022 down from the 27 in 2021. Bob asked how much should be figured for the raises. The Commissioners suggested a 2% increase as a basis to start. That is not a definite figure but a figuring point. The letters for the departments will go out with those changes and updates for next year.
