Alaina Siefker met with Commissioners Schroeder, Schlumbohm and Lammers to discuss a possible new hire for recycling. The need for more workers was discussed as the current ones are going back to school. Commissioner Schroeder brought up accommodating the new recycling room so they can see outside for the cold weather, installing a window in the outside wall. Commissioner Schlumbohm suggested they tour Litter Landing in Findlay to see how they operate in the winter. Commissioner Lammers is reluctant to spend any other money on the program since it is not a revenue stream. Commissioner Schroeder is comparing the benefit to the County residents against the expenses. Commissioner Lammers wants to set a dollar limit on what is put into Recycling each year. The Solid Waste Plan is still in process of being rewritten. Commissioner Lammers wants to see a written plan for the future of the program. Some of the adjustments to the program were discussed. Commissioners Lammers wants to see an infrastructure and personnel plan for up to two years for the program. The County's annual Recycle day was also discussed. The Commissioners agreed that it should take place. A date will be set for this fall once all the collectors are notified. Masks will need to be worn at the collection points and all residents attending can stay in their cars.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers, Cindy Landwehr, Clerk and Steve Coburn-Griffis, Putnam County Sentinel.

The minutes from Thursday August 6, 2020 were reviewed and approved.

Commissioner Schroeder and Tim Schnipke went to view the improvements at the Landfill.
