Mr. Schroeder called the meeting to order with Mr. Lammers by reciting the Pledge of Allegiance.

An Investment meeting was held with Tracy Warnecke, Commissioners Schroeder and Lammers, Kim Redman and

The business agenda was held with Commissioners Schroeder and Lammers, Cindy Landwehr, Clerk and Martin Verni, Putnam County Sentinel.

Sheriff Siefker, Brandi Anspach, Brad Brubaker and Brad Nelson met with Commissioners Schroeder and Lammers to discuss budgetary issues. It was discovered that the courthouse security wages were not included in the current budget anywhere. Originally the security personnel were funded one by the Sheriff and the other by the courts. Since all of those people in that original agreement are no longer here the Sheriff department has assumed the payments. But the amounts were not included within the current year's budget. The need for bailiffs in the courts were discussed. Mr. Nelson explained the required bailiff positions and the

judge's discretionary use of bailiffs. The union wages line need to be increased to include the security wages and also the detectives are now included in the union also. The overtime rates have been discussed as well as the use of overtime to cover the village's that do not have police departments. Those villages do not have funds to reimburse the County for the overtime. There have been some extenuating issues that have created the need for extra overtime recently. Mr. Lammers is asking if the overtime is a greater issue this year, the records would have to be checked and compared. There are villages that no longer have agreements for police services. The numbers were compared and are lower than last year. Mr. Schroeder asked if the beginning of the year has more expenses than other times of the year. The perception of the budget could be skewed due to the purchase order that are done also. A purchase order could be done for the whole year which shows that the funds are encumbered and not available. Transfers will need to be done to cover the shortages that will occur. The Commissioners would like to see an estimate of how much the shortage will be for the year for wages due to the omission of the courthouse security wages. There are a couple retirements coming up that will need to be covered also. The raise amounts for next year are not looking to be as high as earlier predicted, so the union employees will be getting a much higher raise than all the nonunion county employees including the courthouse employees. Has the there been any other discoveries on shortfalls for the budget. The 2020 budget figures will be adjusted for the employees that were transferred into the union. The wages for 2020 were discussed and the inclusion of the union raises, overtime, and uniform allowances. Comp time cash in was also included within the estimated figures. The increase in the requested wage amount was questioned by the Commissioners in how it was figured. Some figures were calculated for the estimate. The Commissioners are trying to get a handle on the budget and understanding all the funding. Changes to the sales tax were discussed, the Commissioners are not looking to make any changes to the sales tax at this time. The transfers and shortage to cover will have to be figured and submitted to the Commissioners so they can prepare for what will be needed.

Dick Schulte stopped in to ask about getting a County Flag donated to the EMS.

The minutes from Thursday August 8, 2019 were reviewed and approved.
