Mr. Schroeder called the meeting to order with Mr. Schlumbohm and Mr. Lammers by reciting the Pledge of Allegiance.

Commissioners Schroeder, Schlumbohm and Lammers held a teleconference with Paulding and Defiance County Commissioners to discuss the setting of the first hearing for the Shane Fitzwater Joint County Ditch.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

A bid opening for the 1.303 acre farm across from the Airport was held

Bid received was from Bryan Maag 211 Easthaven Dr. Ottawa

\$189.56 per acres total bid of \$741.00 for 3 year contract. Cashier ck included as well as proof of insurance.

Gary Lammers met with Commissioners Schroeder Schlumbohm and Lammers to discuss the Avangrid project. Jennifer Peryam of the Lima News sat in on the meeting. The Commissioners received information from Avangrid that they gave to Gary Lammers to review. Mr. Schroeder also gave some information from Dale Arnold, Farm Bureau Attorney for the project as well. Gary Lammers asked if there is a timeframe to go by. The Commissioners would like to have another meeting within the next few weeks to review again. Bob Benroth joined the meeting also. The information included a potential capital improvement agreement. The payment will be the same over the life of the agreement but the beginning payments will be less. The interest from the money was discussed. The negotiations are still ongoing nothing and has been agreed upon yet. Mr. Benroth explained some alternative energy agreements from some surrounding counties and some mistakes that were made. Mr. Benroth does not agreed with the

Commissioners to divert from the original resolution. Commissioner Lammers thinks it will pay off in the future. Since the Commissioners were not included in the project at the beginning it is difficult go back and fix it. It is believed that the people were misled by some of the information they were given for this project. Gary Lammers will review the new agreement and amended resolution. Avangrid would not come in to the County unless an amendment is done. The Commissioners are confident that the project will proceed at this time. The possibilities of Avangrid going bankrupt was discussed. It is thought that someone will come in and buy it. Gary will review the documents and if any questions arise he will ask them. The documents will also be sent to John Leutz at CCAO for review. The agreement of the extra payments were discussed and a concern is if the contract is breached by Avangrid. How can they pay more than what is in the contract. Commissioner Lammers will forward the negotiation spreadsheet to Gary Lammers so he can review that with the documents. There will be time frames to complete once these documents are approved. Avangrid wants to start construction in the near future if it's approved. There are still concerns and the legislation is new so there is no case law for it yet. The issue of the distribution of the payments was discussed and the state has corrected the omission of the Villages, schools fire departments etc. The additional payments could be construed as donations. A precedent is being set by this. The mechanisms in the panels and their lifespan was discussed. There are already efficiencies being developed for them. The Commissioners are more comfortable after the meeting they had on Tuesday with Avangrid. This will benefit the taxpayers.

Bob brought in a bogus email that he received regarding a request to change payroll information for a county employee. Just to inform people to be aware that these spam emails are very prevalent and everyone should be very careful with their emails and financial information. Bob also presented the sales tax figures for the month. The figures are higher again which is optimistic. The solar project construction would also create an increase in the sales tax for the County. The changes in the taxes for Villages were also discussed.

Bob also brought up the request of using the County's bond rating for financing for public bonds for Bluffton University. Allen County already has debt and not as good of a rating as Putnam County's. Putnam County would not be responsible for any of the debt. The administrative fee for using the County rating was discussed. The Commissioner are not in favor of a tiered rate, they would like to keep the .1% for the full amount of the financing. Bob also brought the previous agreement for the Commissioners to review, since we have new Commissioners. The Commissioners have done these agreements before with other entities, Mercy Health, Leipsic Community Center and Bluffton University. Bob explained the use of the rating that was done most recently to overlap and cover two years, with it being split between two years. Bob recommended asking the CIC if any other large projects would be coming that may need financing before the end of the year or next year.

Mr. Schlumbohm moved to adjourn for the day.
