Commissioners Schroeder and Lammers listened to a webinar regarding the American Rescue Plan expenses.

The business agenda was held with Commissioners Schroeder and Lammers and Cindy Landwehr, Clerk.

The Commissioners discussed participating in the One Ohio Subdivision Opioid settlement. The Commissioners are in favor to have Putnam County included in the settlement and signed the form to be a participating entity. A resolution will be presented next week to be included.

The minutes from Tuesday August 3, 2021 were reviewed and approved.

Melissa Bodey of CEBCO, Jonathan Schroeder, Lauri Basinger, Jonathan Fortman, met with Commissioners Schroeder and Lammers and Kim Nordhaus to review the 1st quarter numbers. Melissa said a CEBCO meeting in Columbus will be Sept 3. The total claim numbers were reviewed. The vision claims were reviewed. The vision has been beneficial to the County to be with CEBCO to keep the rates lower. The prescription amounts were reviewed. The sites utilized for care were reviewed. Melissa said CEBCO is doing well and they have not voted yet to pay down the rates for this year. Have the elective services been caught up yet? The claims have increased but no spike has occurred. Are there any new plan designs, Melissa said there will be a new HSA available. Vince suggested the premium amount be increased to \$350 as the target for someone to have to get other insurance for their spouse up from the current \$300. Which would be changed at the beginning of the year. Melissa explained that the app will be changing to Sydney from Engage. Smart Shopper is another enhanced feature that will be available to get the best prices. Tim Schnipke and Joe Burkhart met with Commissioners Schroeder and Lammers to discuss the personnel handbook. The Commissioners asked if they felt they were unclassified employees. Joe said according to ORC he thought he is unclassified. The Commissioners think that Cindy the Clerk is the only unclassified employee within their department. The Commissioners are deeming Tim Schnipke, Joe Burkhart and Mike Schroth to be classified so there is no issue with their earning comp time and cashing in comp time. Mike Klear and Suzy Wischmeyer were also mentioned regarding their employee status. Tim read a resolution, from May 20, 2014, regarding the earning and cashing out of comp time. The Commissioners said all three Tim, Joe and Mike all are appreciated and do a great job.

Vince brought up the improvements to the Grand Stand and if Tim could contact Steve Miller and some other contractors to get interest in doing the improvements.

Tim asked about the additional money available through the CARES act and if any of it will be given to the employees who also worked through the pandemic. The Commissioners are not passing any of that money to the employees they want it to go into something that will still be in use in 30 years for the future people that will still be paying for it. Tim said he is collected the quotes that the Commissioners have asked him to gather. He is meeting with Damschroeder tomorrow to look at the roofs.

Mr. Schroeder moved to adjourn for the day.
