Tim Schnipke stopped in the office. Tim is back part time on light duty. Commissioner Schlumbohm brought up the work at Recycling and said it is looking good. Concrete bids could be put out. Tim Schnipke stopped in to update the Commissioners on the possible new employee. The interview on Friday went well. He wanted the Commissioners to know he would be offering the position. A method for employee retention was discussed of allowing vacation before a year is up.

Board of Election members Tony Schroeder and Kathy Miller met Commissioners Schroeder, Schlumbohm and Lammers to discuss employee compensation for Board of Elections employees. When the director and deputy director got wage increases, they were not given at the same rate that the other county employees received. The Board of Election would like to match it to the raise the other county employees received. The current pay rates for the employees were reviewed by the Commissioners. The Board of Elections employees have received raises when the new employee was brought on. The Commissioners stated those employees received their raises prior to when the county employees received a raise during the year. Board of Election is proposing to give raises again beginning in March. They are trying to maintain increases to get these employees comparable surrounding counties. The Commissioners think that these employees have already received their 2023 wage increase

amounts. The increase that was given mid-year 2022 was not considered a 2023 raise by Board of Election. Since there was not a trained employee in place at the time of election there was additional expense in consulting fees to assist with the election. The employment trend is changing. Board of Election is trying to get employees that will stay and not have to keep training new people. The Board of Election positions has become more stressful with the cybersecurity rules and longer hours of voting. Tony said Kurt will come in to talk to the Commissioners regarding the wages again to confirm. The Commissioners are not in favor of mid-year raises since it is not conducive to keep the budget in check and creates inequalities with other departments. The workforce issues are resolving themselves. Wages may not be the sole employee retaining factor, the possibility of offering to use vacation prior to a year of service. A discussion of increasing the voter turnout was held.

Brian Hilvers and Nancy Erhart met with Commissioners Schroeder, Schlumbohm and Lammers to discuss an open position and union issues. There is an open position for 301. The hours will be changed to include weekends and holidays. Brian is hoping to hire two people for this position that is currently held by one person. There are other positions that are unfilled. There are 16 people on per shift for full service. 3,337 runs currently this year and 700 were done by volunteers. 301 is currently paying overtime to fulfill the need. The 303 truck is doing more 911 calls rather than transport runs. The levy is currently at .65 rate for EMS. The levy revenue keeps the operations going. There is a real estate revaluation coming so the levy will be generating more revenue. The levy is continuous and he would like to increase it to 1.65. Putnam County does more runs than American Township. With the increased revenue a new squad with four people could be in service. The volunteers that do work will get burned out, due to the volunteers that are on the list but do not show up. The County is well equipped but do not have the volunteers to man them. Brian is looking to have paid full time staff to man the units. The Commissioners are willing to let Brian hire staff to fill existing position. With additional on call staff a larger facility for the employees will be needed. Brian invited the Commissioners to go and view some new facilities that have been built in surrounding counties. The equipment that is in storage needs some attention mold is taking over on them. The old squad in storage needs three new batteries. The union negotiations will start in January. Do the Commissioners want to be in on the negotiations? No, they do not. Brian presented a debris plan to determine who would pay for the removal of debris if a tornado would go through the area. There is no plan in place currently. This would be in effect if FEMA would not be involved.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.
