Tim Schnipke and Aaron Vorst met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the outdoor lighting and flag at O-G Road Complex. The flag needs to be replaced more often as it is shredded again. Mr. Lammers also asked about lighting or signs for the crosswalk for the O-G Road Complex.

Alaina Siefker met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the sewer districts and the Village of Ottawa. The regulations are changing again regarding having an operator of record for the sewer districts. The Commissioners are interested in turning the sewer lines over to the village. A meeting will need to be setup with the Village to discuss the sewer districts. The improvements that were done to sewer district #2 they should be paid for by the end of the year. The payments to the Village were reviewed. A call was made to the Village and there has not been a response from them yet. The final numbers on the bills were given to the Village and no calculations were received from the Village. The Commissioners are hoping that the Village will be accommodating as they have been with the water lines. The drainage for the sewer district #2 area will hopefully be completed soon also. There is a meeting set up with the Engineer for sewer district #1 also to discuss the use of Issue I funding. The payments made to Bockrath & Assoc. for the Sewer Dist. #1 drainage must be paid back to the sewer fund. An explanation from the Village is needed to verify the billing rates from the Village for the sewer districts.

Lori Rayle incoming Recorder stopped into ask the Commissioners about getting keys transferred over to her. The keys have not been received from Cathy Recker yet. Lori talked about the updates that are needed for the office.

The business agenda was held with Commissioners Schroeder-via video conference, Schlumbohm and Lammers, and Cindy Landwehr, Clerk.

Lori Brodie of the State Auditor's office stopped in to drop off the 2021 calendars and get an update from Commissioners.

The minutes from Tuesday December 29, 2020 were reviewed and approved.

Commissioners Schroeder, Schlumbohm and Lammers held discussion on an update of the COVID procedures going into the New Year. The Commissioners are thinking to extend the current procedures until the end of January. The case numbers are going down.
