The Board of Commissioners hereby directs the Putnam County Auditor to pay and deposit with the Putnam County Clerk of Courts in the County Road 5 case noted below the additional sum as noted herein as follows:

2018 CV 00136 Putnam County v. Basinger Farms LLC \$1,700.00

The total amount deposited and paid in the above noted case shall be an amount that is seventeen hundred and 00/100 dollars (\$1,700.00) more than the appraised amount of eight thousand three hundred an 00/100 dollars (\$8,300.00) as determined by Putnam County's appraiser, Kevin Schroeder for a total amount of ten thousand and 00/100 (\$10,000.00) dollars.

The Board of Commissioners further direct that upon receipt of funds noted herein and upon the execution of all the necessary easements, releases and dismissals connected with the terms of the settlements, the Putnam County Clerk of Courts shall pay the total amounts deposited in the above noted County Road 5 case to the respective property owner.
