Commissioners Schroeder and Lammers held discussions on offering a settlement for a workers compensation claim for an employee. The figures of the claim were reviewed. The Commissioners are willing to start the negotiations with the employee.

Tom Liebrecht met with Commissioners Schroeder and Lammers and Joe Burkhart to present website design information. ADA compliance certification of the website was discussed. Mr. Liebrecht hosts through another company from California. Mr. Liebrecht explained that there is an add on to confirm ADA compliance on a monthly basis. Mr. Liebrecht has a statement posted on some sites that if an issue arises to contact him and he will correct the issue. There are no specific rules to be ADA complaint is all up to a judge to determine. It was recommended by Joe to have the website checked at least monthly for ADA compliance. Mr. Liebrecht's charge was \$75.00 per website per month. Mr. Lammers said the monthly ADA compliance should be included in his bid. The Commissioners are looking to having website assistance for at least 5 years. Mr. Lammers is interested in getting RFP's and quotes from Twin Elm and Mr. Liebrecht to narrow down the choices. Mr. Liebrecht said all the content of the website would belong to the County. The quotes should include all the costs for all four websites. Security is the biggest issue with the website currently. Putnamcountyohio.gov, sheriffoff.com, putnamcountyrecycles.com and pcops.org are the websites being discussed for changes. It was discussed to have all the websites looking related and being consistent.

Joe will put to together the requests for proposals from the vendors so all the proposals will be for the same services.

Mike Schroth met with Commissioners Schroeder and Lammers to discuss employment and hours. Mr. Schroth came into discuss his overtime hours and to explain some of the hours. He does host hours for people to purchase their dog tags on off hours and weekends. He also explained the care of the dogs and the cleaning needed at the dog shelter when there are dogs being housed. He wants to keep it clean and reputable. Mike does contribute hours that he does not report and he is on call 24 hours a day. The Commissioners suggested flexing his time, if he has a late call to shorten his time the next day if possible. Commissioner Lammers suggested

requesting more part time help to assist with afterhours and weekend care taking of the dogs. Mike said he has a part time person in mind to hire. Commissioners are in favor of him hiring another part time person.
