Commissioners went back on record at 9:25 a.m. no decision were made.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

Commissioners held discussions on Good Friday hours and Covid procedures for the Courthouse. The courthouse will close at noon on Good Friday. And the restrictive COVID essential personnel signage will be removed since the numbers still decreasing.

Commissioners Schroeder, Schlumbohm and Lammers, Bob Benroth and Mike Lenhart attended a Zoom meeting with Amy Sealts and Jeff Loehrke to discuss the ODOT Dist 1 (Transportation Improvement District) TIDS. Amy explained the Community projects that were presented a few years ago and thought they may be possible now. Mr. Lammers asked about specific projects of the round about on N 65 near Red Pig Inn and Arby's, are these County projects or Village projects? Would the road leading to a Dairy Farm be eligible for a complete rehab? Mr. Loehrke explained that any County or village roadway could be eligible. Intergovernmental relationships are promoted through the TID. The Engineer could benefit from working with the TID in stretching the budgeted monies. The TID is trying to become a funding strategist for these projects. Jeff explained the funding available to TID. It is available to work with Economic Development also. The TID funding is flexible relating to jobs (creating and retaining). Mr. Lammers asked about the storm sewer project for the sewer district if that would be eligible? The storm sewer project would not be eligible since it is residential. OPWC would be a better funding source for this project. The dairy farm road could be eligible. Mr. Schroeder brought up Defiance County and their projects. Mr. Loehrke explained some of the projects from Districts 1 & 2 that have been funded and completed. Some projects in Defiance were discussed and their cooperation from Maumee Valley Planning Commission. A map showing the counties with TID's was shared. Project limit is \$250,000 from TID which would also cover design and engineering. Intergovernmental relations is working to get larger projects completed through leveraging different funding sources. A TID must be formed by the County not by the corporations. In the forming of a TID, the County would appoint a five member board. The County Engineer would be one of the members on the board. The TID Committee would review the applications that are submitted and a resolution would be needed to approve the projects. The County Auditor would be responsible for tracking the funding. What liability would be involved? The TID Committee would be an independent body and would need to be insured under the County. The County would have to decide if it is worth the time and effort involved to bring the improvements to the County. The projects would need an Engineer for each project.

The Commissioners have the control to create the TID and would have to researched if they would have the power to dissolve the TID also. Would the TID have the authority to assess taxes? That would have to be researched. A TID can sell bonds. Sample resolutions would be provided for language also. Mr. Schroeder read that the Commissioners would be responsible for the expenses of the TID. Mr. Loehrke recommended talking to a neighboring County that has a TID Committee to get more answers and see how things operate. No other questions were presented from those in attendance. The Commissioners will review and have further discussions later.

Bob said the TID would have the power to levy special assessments to cover the bonds. Mr. Lenhart did call Lorain County and he was told they have additional staff appointed for the TID Committee.

The minutes from Thursday February 18, 2021 were reviewed and approved.

Commissioners Schroeder, Schlumbohm and Lammers met with Adam Schimmoeller to discuss the Recycling Center.

Mr. Lammers move to go into executive session with Commissioners Schroeder and Schlumbohm and Adam Schimmoeller to discuss employee compensation.
