The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers; and Cindy Landwehr, Clerk.

Board of Election members Becky Hermiller, Karen Lammers, Kathy Miller, Carla Tooman and Kurt Sahloff met with Commissioners Schroeder, Schlumbohm and Lammers to discuss Budget Appropriations and County share of voting equipment implementation. WLIO was also in attendance. Commissioner Schroeder asked for some more information on the budgetary requests made by the Board of Elections. Mr. Sahloff felt that the budget was deficient and is hoping for better communication between the two offices on budgetary needs. The upcoming budgetary planning will commence in the next few months. Mr. Sahloff reviewed the requests that had been made already for this year along with the budgetary needs in the compensation, stationary and supplies and equipment lines particularly. The amounts spent in the previous years were compared to the requested amounts. The Board of Elections office looking to upgrade some office furniture so that is the reason for the additional request for equipment. With the equipment upgrades it will hopefully decrease the other voting costs. The additional funding would come out of the County's General Fund. Mr. Schroeder brought the conversation back to the compensation request the Board of Elections explained that the request was to match the previous year's funding and not an increase, since the appropriations were decreased. The agreement for the new equipment was reviewed and the warranty language was corrected. The resolution for the approval of the agreement and maintenance contract for the equipment was submitted to be placed on the Commissioners'

business agenda. The Prosecutor has already been contacted for his approval on the contracts. Mr. Sahloff explained that the reorganization of the Board of Elections will be happening this weekend and the compensation of the director and deputy director will also be reviewed. The appropriation requests will be revisited for the Commissioners to approve.

The first public hearing for CDBG application funding was held at 1:00 p.m.

Pam Sager stopped in to inform the Commissioners of a request for a separate Board for Home Health & Hospice. Commissioner Schroeder talked about the cost allocation plan and the ability of Home Health paying their share. A request was made to the Commissioners to be the charter and appointing body for the new Board and let the current Health board remain over the Health Department.

Joe Burkhart stopped into give the Commissioners an update on moving the power poles near the entrances of Courthouse the cost will be approx \$5500.00 and there would be underground work needed also.

The Pre-construction meeting for the Fairgrounds waterline improvement project was held with Commissioners Schroeder, Schlumbohm and Lammers, Troy Recker and Greg Bockrath of Bockrath & Associates, Mark Knueven of Knueven Earthworks and Maurice Miller from Fair Board. Troy distributed the contract books that have been signed. The anticipated start date is July 8 with the completion date of October 11, 2019. Troy reviewed the scope of the project and the procedures for pay requests. Storage of materials was discussed. Prevailing wage would be in effect for this project so wage reports will have to be submitted. Testing will be done with the inspections. They will be hooking up the dog shelter first so to not have a disruption in water service. Looping the water service through the in-field to reduce the sizes and the costs was suggested by Bockrath & Assoc. all parties agreed to the change so a change order will be submitted.

Greg Bockrath brought up the O-G Road parking lot there is wet soil and stone needs to be added to create an adequate base. Once the drainage is controlled it will be better. A change order will be needed for that project as well.

Mr. Schlumbohm left the meeting.

Back to fair grounds project a curb stop valve could be added also. This would keep the costs within the amount saved by the previous change order.

Maurice brought up some other issues at the Fairgrounds.
