WHEREAS, a request was received from Michael A. Borer, Putnam County Common Pleas Court Judge, Juvenile and Probate; Chad C. Niese Putnam County Municipal Court Judge; and Keith H. Schierloh, Putnam County Common Pleas Court Judge, General to increase the hourly rate for indigent public defense. The increase requested is to adopt the state fee schedule of \$75.00 per hour for both in-court and out-of-court services and caps as recommended by the Office of the State Public Defender and to maintain pace with the surrounding counties. And

**WHEREAS**, the Putnam County Common Pleas Court (General Division), Putnam County Common Pleas Court (Juvenile and Probate Division) and Putnam County Municipal Court request the rate increase to take effect with new appointments as of January 1, 2020. now therefore, be it

**RESOLVED**, that the following fee schedule shall become effective as of the 1<sup>st</sup> day of February, 2020. Attorneys appointed to represent indigent Defendants from and after the effective date of the Resolution shall be paid at the rate of \$75.00 per hour of representation for out of court work and \$75.00 per hour for in court work up to the following maximum amounts for the offense classifications and other proceedings.

For Juvenile proceedings the reimbursement amount is also at a rate of \$ 75.00 per hour for both in-court and out–of-court services. Reimbursement will not be made for non-attorneys appointed as a guardian ad litem. In abuse, dependency, and neglect cases, both the attorney and the guardian ad litem may bill up to the maximum fee allowed by the county.

Withdrawal of Guilty Plea

Reimbursement for expenses associated with providing representation shall be made when submitted with the attorney's fees certificate (OPD-E-202) and approved by the trial judge. Expenses include, but are not limited to, such items as expert witness fees, polygraph examination costs, parking and meal expenses, long distance telephone calls, copying, and other necessary items as approved in the discretion of the court. The maximum allowable fee to be paid for expert witnesses is \$750.00 and must be incurred with court approval. In extraordinary circumstances and with prior written approval obtained by the court and the Board of County Commissioners higher fees may be approved.

If defendant enters a guilty plea to the charges of the indictment or complaint, the attorney in that trial court shall be compensated at a minimum of \$250.00. If the charges are dismissed against the Defendant prior to trial the attorney shall be compensated \$150.00.

Additional re-imbursement for extraordinary cases will only be made with the approval of the trial court and permitted by the county fee schedule.
