Mr. Schroeder called the meeting to order with Mr. Schlumbohm and Mr. Lammers by reciting the Pledge of Allegiance.

The Commissioners attended the Elected Officials meeting held in the lunch room hosted by the Prosecutor.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers; and Cindy Landwehr, Clerk.

Brad Brubaker came in to discuss with Commissioners Lammers and Schroeder the payment of the Zuercher software bill and the remaining portion that needs to be paid.

Commissioners Schroeder, Schlumbohm and Lammers met with Sheriff Siefker, Mike Lenhart, Engineer and Judge Niese to discuss the engine Brake usage (jake brake) and the enforcement within the County. The engineer shared his policy that shows the requirements for creating the restricted area for engine brake. Judge Niese cannot give any input on the enforcement. He recommended the Prosecutor be included instead of him. The Judge said he mostly sees ORC violations rather than Village ordinances. Judge Niese left the meeting. The resolution passed by the Commissioners in May of 2018 was reviewed. The enforcement by surrounding counties was questioned. There are Villages that have the restricted use enforced. The wear and tear on the roads was discussed also. Gary Lammers will be contacted for an opinion also. Mr. Lenhart has a log of the requested locations for the engine brake restriction, it is not many currently. The County can also place them on a State Highway. Is it wanted to be enforced throughout the whole County and should it be posted on all entry points to the County?

The discussion of the Zuercher payment was resumed among the Commissioners with Sheriff Siefker and Brad Brubaker. The bill was reviewed and the completed payments were reviewed. The amount the General Fund would pay was reviewed by Brad. The administrator never discussed with the Commissioners the payment portions for the Zuercher project and that any portions of payment would be funded by the Commissioners out of the general fund and it was not budgeted into the Sheriff/ Jail 2019 budget for them to pay either. Brad explained the process and how the software works from receiving a 911 call up to an arrest resulting from the call. The Villages could also purchase licenses to be included with the system too. There are other mobile services that are included. The 2019 budget will be reviewed to confirm that the funds have not been appropriated for this project. Brad explained the wireless 911 funding to pay for replacing fire department pagers and eventually all portable radios.

The minutes from Thursday January 31, 2019 were reviewed and approved.
