Tim said the crossover driveway tile was not put in correctly. The tile needs to be lowered so the wet spot will drain. The water is ponding before it gets to the tile and does not drain. There is dirt coming to the landfill from the river diversion channel project. Duke Imm left the meeting. There are other spots on the mound that need more dirt also. The contractor that brings the dirt will dump it wherever it is needed. If no dirt comes from the river they will use the hard ditch dirt from the landfill ditch cleaning.

The waterline improvements at the fairgrounds were also discussed.

Tim presented some bills for repairs need at the Ag Complex that were caused by the renters.

Tim also brought up the newly crushed stones used by the Engineer and if he had intentions to pay for want he uses and the improvements needed for the driveway to the salt building.

Vince asked about the estimates for a new lawn tractor. Tim is still collecting quotes to present and evaluating the other equipment for trade in toward a new tractor.
