Tim Schnipke stopped in to inform the Commissioners of some upcoming expenses for continuing education for the spray licensure for the maintenance staff and improvement to the maintenance office. Tim also mentioned a request from the Fair board for electrical improvements at the Fairgrounds. Tim is getting the materials list and is asking if labor should be included also. Some other electrical upgrades were discussed also. On the courthouse project the mason and Trisco is cleaning up and will be back when it is warmer. Tim said the concrete was done in the Ag Complex on Friday. A drain will be needed for the new recycling area. ALL Excavating showed up to start grinding the stone.

Commissioners Schroeder, Schlumbohm and Lammers attended a workforce development meeting at 9:30 a.m. at the Putnam Co CIC.

Commissioners Schroeder, Schlumbohm and Lammers returned to the office to participate in a 10:45 a.m. Joint county conference call with Allen County Commissioners Sneary and Noonan to discuss a resolution for combining maintenance projects on Cranberry Creek. Mr. Sneary moved to approve the resolution and Mr. Schroeder seconded the motion. All Commissioners present voted yes.

The business agenda was held at 11:00 a.m. with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday, January 16, 2020 were reviewed and approved.

Commissioners returned to the office.

Commissioners Schroeder, Schlumbohm and Lammers held discussion on the airport appraisal. The land around the airport will be designated for airport use and no other development. An appraisal was done and the Prosecutor is working on the land purchase agreement. A grant will be applied for by the Airport Board and the Commissioners will be paid for the land through the grant. A map viewing the 3 parcels designating Airport use was viewed. The area is approximately 11 acres total.

Commissioners Schroeder, Schlumbohm and Lammers met with Greg Luersman to discuss the flood plain and the diversion channel. Steve Coburn Griffith joined the meeting. Greg said he has been getting phone calls the past few weeks about the dirt from the diversion channel and placing it in low spots in a flood plain. In the plans for the diversion channel the soil cannot be put back into a flood zone. Bockrath and Assoc. and the Put Co Engineer has also been in on the conversation. The village of Ottawa has land that some of this dirt could be put on. The county does own land that could be storage. There is some going out to the Landfill. It could be a challenge to get rid of the dirt. Greg is concerned about the dirt being put back in to the flood zone. The Maumee Valley Conservancy District is looking to get rid of the dirt and the contractor would have to find an approved sites. The dirt could be gradually moved from the approved site and into a flood zone. How can this be policed? The bid opening was last week for the contractor for the diversion channel. How can this be controlled? A proposal of having people getting the dirt signing contracts about where the dirt will go. The Commissioners do not have an answer and it should have been addressed in the bidding documents. Bockrath & Assoc. will do what they can to control the dirt going back into the flood zone. Mr. Schroeder said more education of the people informing them of the changes that are not allowed, is an option. The Planning Commission website has the regulations written out.

Mr. Schlumbohm moved to adjourn for the day.
