Melissa Bodey, of CEBCO met with Commissioners Schroeder, Schlumbohm and Lammers; Denny Recker of UIS and Laurie Basinger of Fortman Insurance to review the 3rd quarter reports. Melissa reviewed the claim totals the enrollment has increased since October of 2017. Putnam County is on the smaller side of other Counties that are with CEBCO. The vision claims totals were reviewed. The Anthem payment totals were reviewed. The care options for the County were reviewed as to urgent care versus emergency care. The top health conditions and prescriptions drugs were reviewed for the quarter. Melissa also had Live Health online information to review. Life Health is a virtual office visit option available to anyone on the insurance. The usage number were reviewed. The Behavior Health numbers were reviewed also. EAP Employee Assistance Program was reviewed for eligibility and different options available, medical, mental, financial or legal. The prescription use of marijuana was discussed and the costs involved. The preparations for the Health Fair was discussed.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers; Cindy Landwehr, Clerk.

Brenda Troyer and Lori Brodie of the State Auditor's office came in to introduce to Lori to the Commissioners she is the new regional liaison and inform them that the County's Audit has been started.

Tim Merschman stopped in to talk to Commissioners Schroeder, Schlumbohm and Lammers to talk about having a Skilled Trades representative at the Elevate job event. Mr. Merschman did talk to Mrs. Wischmeyer at Job & Family services. At the current project at Pro-Tec there are many skilled traded people working that are from out of the area and even State. The apprenticeships available were discussed. Tim said the high schools should still be offering Shop Class and Home Economics classes. Tim also had a recommendation on a Health Board member.

The minutes from Thursday, January 17, 2019 were reviewed and approved.

The Dog Warden Mike Schroth met with Commissioners Schroeder, Schlumbohm and Lammers to give the annual report. State law says to do an annual report. He passed out a sheet to them showing how much they brought in for dog license fees. Two lifetime licenses were sold. The Auditor's office makes the rules on the vendor/kennel licenses. Mike said some people do the kennel licenses. Mike Schroth said it would be up to the Auditor's Office to change to let him take over selling the licenses himself. State Law says Auditor's Office sells the dog tags and their office can have up to 15%. It is not clear in the law though what the 15% is of. Mike thinks it should be 15% of the dog tag fee only. But right now they get 15% of all the income he brings in. Fairfield Online Service current is free. \$4500, they mail notices and text or email reminders. Comr. Lammers said we aren't going to switch how the dog tags are being sold. Mike said the Auditor's Office is getting more than their fair share of the budget. The commissioners said we appreciate the work you do. Comr. Lammers said if you start collecting out there, we would have another account that would have to be audited in our office. Mike said the commissioners pass a resolution saying what that % is for the Auditor's Office. Mike said the better job I do, the more the Auditor's Office gets and the less they would have to take from the general fund. Mike said Barb in the Auditor's Office wants to know if they could add one day for the dog licenses to get paid. The last day is a Thursday and she thought it would be better to extend one day to include Friday. Mike said to him it isn't going to be a big deal to him so he told her he would ask. In his opinion, he said if we are going to extend it, he thinks we should extend it to the 5th. Comr. Schroeder said unless there is inclement weather that closed the courthouse for an extended period that we should not change the date. Comr. Lammers asked how much overtime do you turn in for a month? Mike said it varies. He said sometimes it is 20-30 hours a pay period. Comr. Schroeder said if you work some overtime, could you come in a little late or leave a little early especially if you know you are going to be working some later in the day, etc. Mike said he just worries about when he has dogs in the shelter and keeping it clean.

Commissioners Schroeder, Schlumbohm and Lammers attended the first ditch hearing for the Martin Schroeder Dt. #994.

Dean Meyer, Village of Ottawa Mayor, stopped in to drop off the agreement between the commissioners and the Village for the transfer of the waterline for our review to Commissioners

Schroeder, Schlumbohm and Lammers. Mr. Meyer said that their attorney has reviewed it already. He wanted to bring it to us for our review now. We will also send it to Gary Lammers. Comr. Schlumbohm asked if we would be getting the sewer memorandum of understanding. He said their attorney is still reviewing that but when we are ready to sign them, we should be able to do them both at the same time.
