Lori Rayle stopped in to talk to the Commissioners about the increase in the gas card amount for the employee participants in the wellness program. What the reasoning was for the increase. The Commissioners are watching to see if it changes the participation level.

Gary Lammers held a teleconference with Commissioners Schroeder, Schlumbohm and Lammers regarding his retirement and he wanted to talk to the Commissioners about reappointment until the party can meet to appoint. Gary is planning to retire and no longer participate in OPERS as of January 31. The Commissioners will need to appoint an interim replacement for the County Prosecutor position. Gary is asking the Commissioners to reappoint him to the Prosecutor position as of February 1, until the Democratic party will meet. The Commissioners have no reason to not support Gary and to reappoint him. Gary has tried to serve the County as best as he can and hopes his record speaks for itself. With all the potential changes to retirement he is trying to do what is best for his family. Gary will resign to OPERS, he has talked to the Auditor and Board of Elections also. Gary reviewed the ORC for holding the office and the amount of time served to determine if a re-election is needed. There is a special election scheduled for August, since the deadline for the May primary will not be met. Gary truly appreciates the support of the Commissioners.

Commissioners Schroeder, Schlumbohm and Lammers held discussions with Jeremy Maag regarding the ARP funds and the requests that have been received. There is a new company in the county that took over the eastern side phone and internet service, they may be invited to get an allocation of the ARP funds for improving internet service within the County. The new merchant /junior fair building will go through the ARP fund. The new air handlers for the courthouse are qualified ARP expenses. The request for the transport van by the jail may be allowable will be discussed on Thursday. The other approved requested were reviewed some have been paid already. The planning and designing for the fairground's improvements can be paid from the ARP funds. The new EMS vehicles will be paid for by the EMS. Jeremy explained that some of the stipulations are relaxing regarding some allowable expenses. The next round of funds is expected to come in June. All of the expenses must be documented and auditable, so the funds cannot be transferred in to the general fund for revenue replacement. Renovations are desired rather than new construction for COVID purposes. The workforce development request was reviewed and to remember that these funds must be encumbered by 2024 and spent by 2026. There will be an end to this funding, so if this is to fund a job position it funding will be done in 2026. If the Putnam County industries do not contribute any funds the County will not pay the whole amount. A final amount for the CIC request has not been officially approved yet by the Commissioners. Jeremy explained the federal requirements for the reporting for the ARP funds, which are different than the reporting on the COVID-CARES funds that were received which came form the state. Provide as much documentation as possible to verify the expenses. The Engineer has requested ARP funds as revenue replacement for needed improvements. The Commissioners know he will use it properly. The lost revenue formula is no longer valid. The amount for the grandstand improvements of \$325,000 will come from the first round of funding.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday January 20, 2022 were reviewed and approved.

The Commissioners, Joe Hohlbein and Alaina Siefker held an interview with Bill Williams for a Recycling Driver position. Joe said he will have Adam get with Bill to see when he can come and watch the pumping of leachate to see if he thinks he could do the job. After Bill left, Joe let the commissioners know what he thinks about the options of the North vs South part of the building for moving recycling in the back. Commissioner Lammers said he would like to do whatever would be most efficient for everything especially the processing and having the employees right there to help on the sort line when no customers are bringing product in. Joe wants to go to Auglaize County to check out a Mariner Baler. Commissioner Schlumbohm said wouldn't you want an auto tie baler. Joe said it could be an option. Efficiency should increase with an auto tie. John said he is going to ask Tim to price out an overhead 12 ft. door. Joe said he can move the glass out back also. Joe is looking at rotators for the forklift for the glass. For the concrete pad out front where the bins are now, maybe a roof could be put on it and rented out. Commissioner Lammers said look at baler prices and look at grants through workers comp so could we look at the company that Van Wert used to do their grant.

Mr. Lammers moved to adjourn for lunch.

Nathan Meyer met with Commissioners Schroeder, Schlumbohm and Lammers to discuss the maintenance shed at the Fairgrounds. Nathan presented a quote for insulating the shed. The Commissioners asked what the plan is from the Fair Board. They would like to get it done so the paint does have to be stored in the office. John asked about the fundraising assistance from the guy for the exposition center. John is on board with The Commissioners paying half for the insulation al long as the Ag Society does not waste money on the fundraising assistance for the expo center. Using blue board was also discussed. If the Commissioners would pay to get the ceiling done the Ag Society would install the blue board and blow in the insulation and the Commissioners would pay for the materials. The Commissioners will pay about \$12,280 toward the project up to \$12,500. Nathan had some quotes for tables & chairs and partitions for the new merchant/Jr fair building. Nathan asked about wireless services, the Commissioners said MetaLINK is planning to put in 5G service which may cover the fairgrounds. Nathan said there are some updates to the Fair Managers Plan where they are now allowed to posted notices on the website and they can now hold 50/50 raffles during the fair.
