- 1. RESPONSIBILITIES: To provide, enforce and abide by all the requirements as stated in Chapter 3750, on behalf of the Local Emergency Planning Committee (L.E.P.C.)
- 2. COMPENSATION: Compensation for this "agreement" shall be fifteen thousand dollars (\$15,000.00) paid in one lump sum to the Putnam County Emergency Management Agency (E.M.A.). The amount of compensation shall be "negotiated" each year by: the Board of Commissioners, Chairman of the Local Emergency Planning Committee (L.E.P.C.), and the Emergency Management Agency E.M.A. Director/Coordinator.
- 3. TERM: The "agreement" shall begin with the date of the signing of this contract and ending on February 1st, 2022. The contract shall be renewed each year prior to February 1st, and may be cancelled with ninety (90) days written notice.
