The Commissioners' organization was done for the 2019 year.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers; Cindy Landwehr, Clerk and Martin Verni, Putnam County Sentinel.

Dean Meyer, Ottawa Mayor stopped in to talk to the Commissioners during their business agenda about an exception within the emails corresponding with the EPA that references the Village of Ottawa as unwilling to help. And that is not the case. Mr. Meyer explained that the new EPA regulations are very demanding. An extension has been received by the County from the EPA.

The minutes from Monday December 31, 2018 were reviewed and approved.

The Commissioners held discussions of revising the minutes of Thursday December 6, 2018.

Commissioners' held discussions on the following matters:

Wellness & Health Fair- Commissioners Schroeder and Lammers filled Commissioner Schlumbohm in on the process of the wellness program. Commissioner Lammers asked what the benefit is for the booths for the wellness day that is scheduled for January 23. Comm. Lammers tried calling Jon or Laurie from the insurance company and left a voice mail for them to call back. Comm. Lammers said the problem he has is that he does not want it to disrupt the security desk. Comm. Schroeder said we get a grant for \$13,400. We need to find out what the requirements are for us to receive the grant money. Comm. Lammers said they pulled a lot of the money they used to pay for the wellness program. We will see if the insurance company gets back to us and we will ask what the requirements are. Adam Cupp returned a call to the Commissioners regarding the parameters for the funding for the wellness program. Adam will reach out to CEBCO to see what the requirements are. Adam was thinking we were at level 2 or 3 of the stages of the wellness program. Mr. Betscher handled all the aspects of the wellness program and had all that information.

Mr. Bill Klausing came in to talk to the commissioners about all the semis that keep coming down Road 7. He is right on the corner of J-6 and Road 7. He said the semis are getting worse out there. Comm. Lammers said it cannot be enforced, you have to let the semis go through the

roads. He said he just wondered why it was bad now and years ago it wasn't and just wondered if they knew about it. Unless there is some kind of weight limit or bridge, there is nothing they can do to keep them off of the road. Comm. Schroeder asked him if needs paved. Bill said that would be a good idea. Comm. Schroeder said the engineer could repair the road and he could go up to the Engineer's Office and talk to them about it.

Landfill Wetland plans-A quote is being sought from Bockrath & Assoc. for the plans to compare to the quote received from Bowser-Morner. The results from the soil borings are being requested from Bowser-Morner.

Operations of water distribution system-It will be decided after the meeting with Columbus Grove if services from Poggemeyer are needed.

Commissioners met with Jeff Vance and Ken Wright of Columbus Grove to discuss the operations of the County's water distribution system. Alaina Siefker Commissioners Utility Billing and Martin Verni from the Sentinel joined the meeting. Comm. Lammers said this meeting it to determine scope of work. March 31 was our extension date. I envision this being handed off to someone to run this. We don't want in the sewer and water business. Ottawa wants to take over the water right away but not the sewer but we want them to take it all. Comm. Schroeder said mainly about water at this time. Jeff Vance said Grove is not interested in taking it over completely. He said he was under the assumption this would be a short term deal and were just wanting to help us out until we come to some agreement with Ottawa. Comm. Schroeder said he hopes that this is just a short term deal. Comm. Schlumbohm said contingency plan is not new. Jeff said there are a lot of new items that had to be added for this one. As of now, Mayor said we have no operator of record as of right now. So if something happened right now, would you be able to come and help. Jeff said we would have to have a contract. We could hire a private contractor. Jeff said Poggemeyer's amount for price quote is a good deal. Comm. Schlumbohm said an operator of record is needed right now and Comm. Lammers agreed. Comm. Lammers said we need to decide if we want to do a contract on an immediate basis or do you need to get with council first? Mayor Ken said yes we would need to go to council first. Council is aware of the quote. Comr. Lammers said in the interim, would you be ok with us calling you? Mayor Ken said he would monitor the repair and do the testing until we get something in stone. It would just be Jeff's responsibility to make sure it is done right and we would have to have someone do the work. The bill would come from the Village of Grove to us. Comm. Lammers asked if we have are good to have Grove go to council for sure then. Jeff said the paper with quotes are good up to a year. He said if we get something done early we can just let them know. Mayor Ken said they are here to help out the situation and just want to work with whoever needs the help if they can help. That is the only reason we are here, to help out someone that needs it. It is not to spite anyone. They don't need the money so it isn't to take the counties money either. They just want to help. Mayor Ken said he just doesn't want a liability situation. He just wants to make sure that they will be covered. He asked if Gary could draw up a contract. Comr. Schlumbohm said they will have Gary Lammers review everything and work on a contract. Village of Columbus Grove council meeting is January 14, 2019. Comr. Schlumbohm said he has confidence that for the good of the community the Village of Ottawa would help if something broke or happened in case parts are needed. Jeff said we need to find out from the Village of Ottawa if they will still be reading the meters to send us a bill for that line. Jeff said he cameraed Pohl, SD#1 and SD#2 for us about 8+ years ago. Your sanitary pipe probably needs fixed. Your sanitary system should be sealed good enough that it

can lay in water and you don't have the I & I. When we looked at it then, you had some I & I from the residents and some pieces of pipe that probably had cracks typically at manholes. Pipe checked but not coated. Can hire a company to come in and camera and fix some pipes. Comr. Lammers asked who we can hire to fix the sewer. Jeff said we need to clarify with Ottawa if they find issues, will they let us know. Comr. Lammers said we need to hire someone to come in and help us fix the sewer I & I. Jeff said contact Gary Hermiller. He has a camera and he was involved the last time they were looked at.

A conference call was held with Laurie Basinger regarding the setup of the Wellness day within the courthouse on January 23, 2019 and not moving the security desk and scanner.

The Board of Revision reorganization meeting was held.
