Commissioner Lammers attended a Zoom meeting with the COVID Task Force.

Commissioners Schlumbohm and Lammers attended the Elected Officials meeting in the Assembly Room.

The business agenda was held with Commissioners Schroeder-via video conference, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday December 31, 2020 were reviewed and approved.

Kevin Niese met with Commissioners Schroeder-via videoconference, Schlumbohm and Lammers and Tim Schnipke to discuss a schematic office design. Kevin shared the plan he drew up. Kevin said they need to know who will be in the offices, how any people, and what offices specifically for their needs. Once the size of the building is determined then a cost can be figured. He said there will be costs involved in meeting with all the offices to determine the need also. Vince shared that some of the information is not reasonable. There are offices that are not interested in moving such as the Auditor. A building will be needed to replace the Annex (Armory) building out of the flood zone and the proper size. The Commissioners should have the responsibility of determining the location of offices to optimize work flow. Kevin will determine the size needed for each office. The use of common rooms was discussed for conferences, restrooms, server and electrical. This is to look at the offices that need to be housed within the courthouse and those that do not need to be housed within the courthouse. The Commissioners do not need to be within the courthouse but the Prosecutor should be. The offices could be moved and it would be a great undertaking to move any office location. Commissioner Lammers said the Annex could be repaired to be useful for another few years. A new administrative building could be built to accommodate the offices and any expansion they may need in the future. The money is the taxpayers and should be spent to serve the taxpayers. The options are A)to repair the current building (Annex), B) Building a small building to replace the departments within the Annex or C) build a larger administration building to accommodate the offices that do not have to be housed within the courthouse so the Prosecutor could move in along with Probation and Veteran services. The Veterans office was housed in the courthouse previously. Commissioner Schroeder said replacing the Annex could be an option by just giving them an efficient building the size that they need. Commissioner Schroeder is not in favor of just repairing or band-aiding the Annex. It would be more than a year to build anyway. The

Commissioners asked what it would cost to repair the Annex to last another few years. There are two HVAC systems within the Annex that need to be replaced soon and the rear entrance needs to be replaced. This could cost approx. \$100,000. What departments would go in to a new office building? A new building the size of the current Annex would house the four departments from the second floor. Kevin will come up with some plans for the two different buildings and price difference will be factored into discussion. Either way the Annex will be need to be repaired to last another 2 years at least. Some way to repair the back steps of the Annex were discussed, they are not in good shape. Commissioner Schlumbohm suggested having Trisco do the repairs based on their workmanship on the new steps and ramp at the courthouse.

Mr. Schlumbohm moved to adjourn for the day.
