Commissioners Schroeder, Schlumbohm and Lammers attended the county budget hearing with Jeremy Maag and Bob Benroth with the Auditor's Office. The submitted budget figures were reviewed. Common Pleas has an item they need to check on. Some figures need to be confirmed to see if they were entered correctly. Some of the figures included the carryovers amounts rather than entering new year figures. The courts line items were reviewed. The compensation lines did increase, which in this economic climate, wages will increase. The increased percentages in appropriations by each department were reviewed. Bob explained that a system upgrade is coming in the next few years for the financial reporting, and along with it a large expense for the upgrade. The real estate system will have to change also. Some other line items were reviewed and it was asked if a few of them could be lowered more? The Sheriff and Jail's budget was reviewed. The wage increases and other expenses went up. The revenue figures are down since there is not prisoner housing from out of county coming in. The health insurance increase was discussed. Jeremy said to figure it as a 5% change just to have an amount. A meeting will need to be had with the Sheriff's office to review the new years figures. It was advised to not keep granting a money over the set budget, then the carry over balance will be gone in a few years. If money is transferred to be spent from different lines then the lines not being spent should be decreased. The board of elections budget was discussed their request went up. It is wanted to keep the budget within balance since the gaps will only get bigger.
