Mr. Lammers called the meeting to order with Mr. Schroeder and Mr. Schlumbohm by reciting the Pledge of Allegiance.

Tim Schnipke came in to give the Commissioners an estimate for cameraing the drain lines at Fairgrounds was approx. \$18,000. from Gary Hermiller-Ohio Sanitary Services. The lines will be mapped once they are found. The jet and the camera will be used. Since the jet will be used it will clean out the tiles while it goes through.

Mr. Schroeder brought up using the Health Dept's sign for the fair. He has talked to the Health Department about it, the sign can be used by any department. The floor covering at the Health Department was discussed the quotes will be reviewed.

There will be some concrete work done at the Airport on the north side of hangars, the hangars doors will be replaced also.

Steve Coburn-Griffis stopped in to talk to the Commissioners about the Powell Creek Solar project. The Commissioners are excited about them coming in and getting started. The Commissioners mentioned the other smaller solar projects within the County also. The payments from the solar projects were discussed. The time span of the payments coming was reviewed, it will be 30 years. The local payout is \$5.25 million over a five-year period for property tax. The Alternative Energy Zone and PILOT (payment in lieu of taxes) was also explained. The Commissioners explained how the Powell Creek project drew ore attention to the County from other solar companies. The American Rescue Plan funds and how they will be used was explained. The proposed plan to reduce sales tax with the ARP money was also explained. The distribution to the fire departments was also explained. There is are discrepancies on the allowances to use ARP funds to replace tax revenue. The tax collections on property versus income taxes were discussed. The ground use of the solar fields were also discussed. The possibility of using the ground as pollinator patches through CRP may be an option.

The Commissioners want to have discussions on dropping the sales tax. The allowances on when to drop to have it reduced by January 1 will be reviewed. The Commissioners want to use the ARP funds to cover the sales tax and there is money in capital improvement to cover the new building expenses if needed. There is a division on when to lower, another suggestion is to wait until June 1 to lower. Commissioner Lammers wants to do it as soon as possible. The other Commissioners would like to wait until the additional money is more certain to come in, they would like to be conservative about the decision, so they will not have to raise it again with in another year or two. The timing on this decision is in conflict, not the decision to lower.

The business agenda was held with Commissioners Schroeder, Schlumbohm and Lammers and Cindy Landwehr, Clerk.

The minutes from Thursday July 15, 2021 were reviewed and approved.

Judge Schierloh stopped in to have the Commissioners sign the T-CAP agreement for another 2-year term. The rates of cases in divorce, domestic violence and sex are up from the pandemic shut down. The drug cases were down until the shutdown was over, they have since picked back up.

Tim Schnipke stopped back in to let the Commissioners know he is collecting quotes for different projects including replacing the remaining roofs at the Ag Complex. The quotes are good for 30 days currently, usually there are good for 90 days.
