The best quote was from J.L. Wannemacher in Ottoville on a Ferris. The John Deere is a rough riding mower there is no suspension. Ferris is the commercial version of Simplicity. Wannemacher does not want to trade but gave a quote of \$14,995.00. Gary's Repair will give \$8,500 for a trade-in, Continental will give \$10,188 for trade in. The book value for the John Deere is between \$8,000-10,000. Continental will trade for about \$5,000. The mower to be traded is 13 years old. There are parts on the Deere that will need to be replaced. The decision is up to the Commissioners to trade. There is a \$1,000 bid assist for state bid. A resolution will need to be done for a trade in.

A question of auto door openers on the new building was brought up. Tim will get it set up to install on a door near the handicap parking area. Commissioner Lammers joined the meeting. It was questioned if an auto door opener is an ADA compliance issue. The position of the opener buttons was discussed. The courthouse elevator has been down, there are sensors on the third floor that were not lining up due to a spring being broke. The springs were all replaced when the new elevator was put in. The broken spring was replaced so we should be up and running again. The replacing of the elevator was discussed.
